

ORDER

SECTION 35, THE MINING ACT, R.S.O. 1990

ORDER NO. O-P-90/20

The SURFACE RIGHTS and MINING RIGHTS of the areas outlined in red on the attached sketch, situated in the Township of Nesbitt, Porcupine Mining Division, were withdrawn from prospecting, mining claim registration, sale and lease by Order W-P-84/20.

Withdrawal Order W-P-84/20 is hereby revoked and the lands are reopened for prospecting, mining claim registration, sale and lease, unless the lands are otherwise not open for these activities under any other provision of the Mining Act.

This order comes into effect on November 5, 2020 at 10:00 a.m. eastern standard time or eastern daylight saving time, as the case may be.
