

ORDER**SECTION 35, THE MINING ACT, R.S.O. 1990****ORDER NO. W-P-09/19**

The MINING RIGHTS of the area outlined in red on the attached sketch, being mining cells 42A11G081, 42A11G082, 42A11G083, 42A11G161, 42A11G162 and 42A11G163 situated in the Township of Wark, in the Porcupine Mining Division containing 65.053 hectares more or less, are hereby WITHDRAWN from prospecting, mining claim registration, sale or lease.

These areas are WITHDRAWN while the Ministry of Energy, Northern Development and Mines reviews the status of the lands.

Saving, excepting and reserving hereto and herefrom, all other lands patented, sold, leased or otherwise alienated by the Crown at the date of this Order.

Any alienated lands lying within the limits of this withdrawn area that revert to the Crown subsequent to the date of this Order will automatically be considered to be withdrawn as part of this Order.

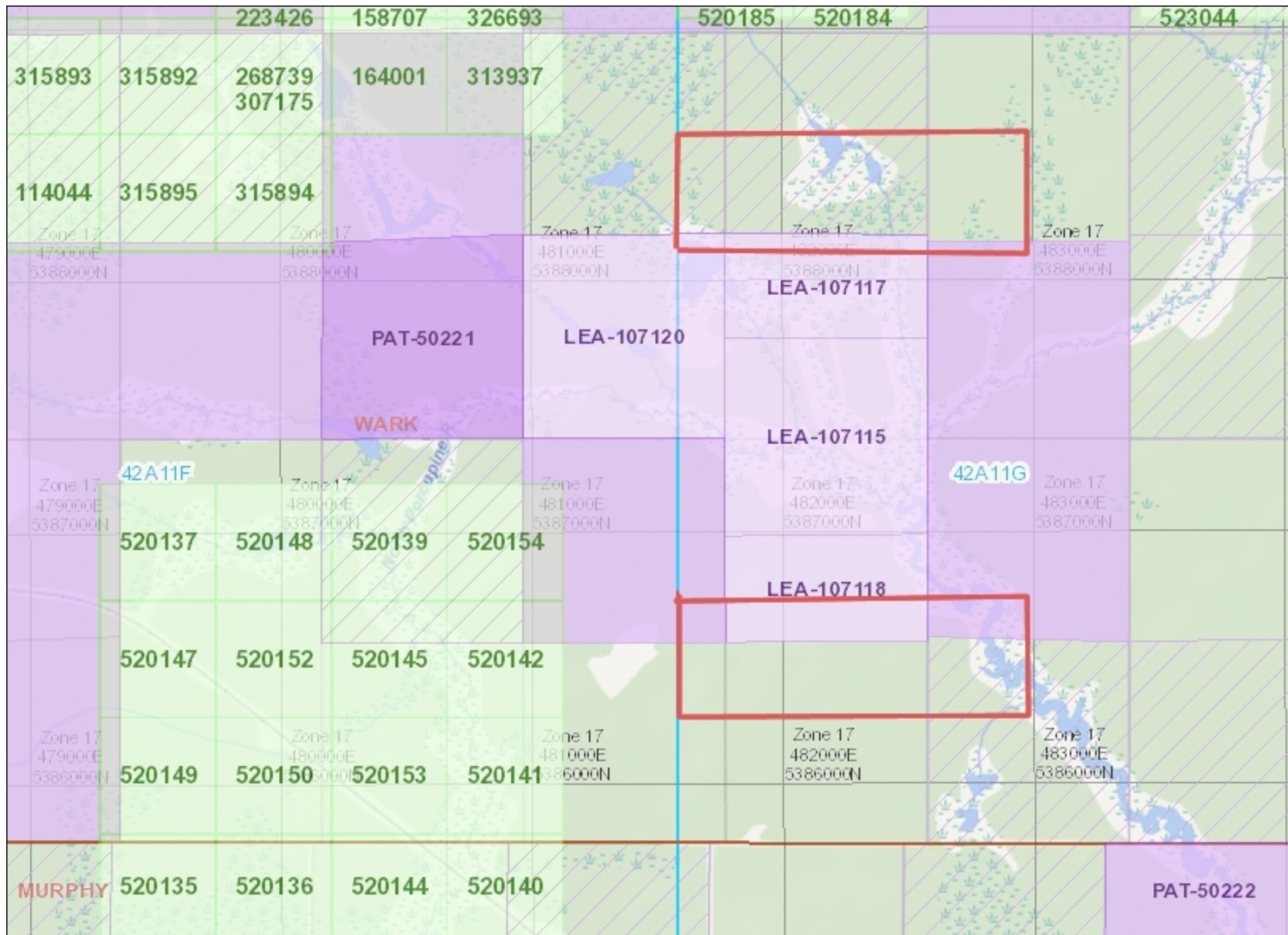
