SECTION 35, THE MINING ACT, R.S.O. 1990

ORDER NO. W-P-84/20

The SURFACE RIGHTS and MINING RIGHTS of the area outlined in red on the attached sketch, situated in the Township of Nesbitt, Porcupine Mining Division, containing 205 hectares more or less, are hereby WITHDRAWN from prospecting, mining claim registration, sale or lease.

This area is withdrawn while the Ministry determines the status of the lands.

Any alienated lands lying within the limits of this withdrawn area that revert to the Crown subsequent to the date of this Order will automatically be considered withdrawn as part of this Order.
