SECTION 35, THE MINING ACT, R.S.O. 1990

ORDER NO. W-TB-44-04

The MINING and SURFACE RIGHTS of the area outlined on the attached sketch, situated in the Onaman (G-0105), Coughlan (G-0026), Castlewood (G-0022), and Fullerton (G-0040) Lakes Area, Thunder Bay Mining Division, and containing 7,297 hectares more or less are hereby WITHDRAWN from prospecting, staking out, sale or lease in accordance with the terms of this order

This area is withdrawn pending review by the Ministry of Natural Resources as a proposed addition to the parks and protected area system.

Saving, excepting and reserving hereto and herefrom, all other lands patented, sold, leased or otherwise alienated by the Crown at the date of this Order.

Any alienated lands lying within the limits of this withdrawn area that revert to the Crown subsequent to the date of this order will automatically be considered to be withdrawn as part of this order.

This order comes into effect upon signing.



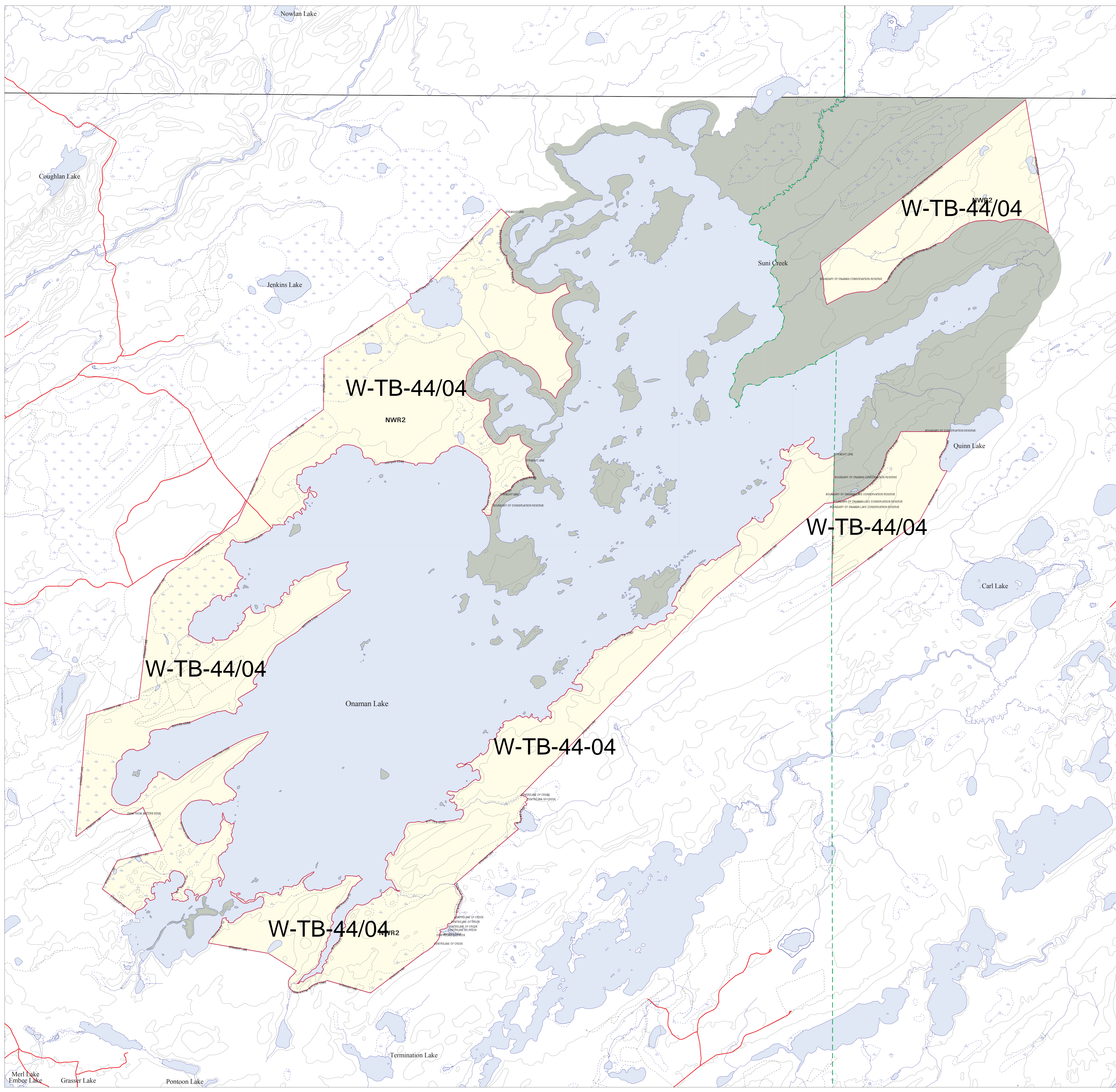
