

## 1.0 Introduction

This report deals with the logistics and results of a bulk sampling program carried out on the "Jocko River Property" in Jocko Township in the Sudbury Mining Division between April 1<sup>st</sup> and September 31<sup>st</sup>, 2004, Test marketing of split flagstone product was undertaken following acquisition of the sample.

The Jocko River Property is comprised of 1 - 4 unit mining claim S 1246599 recorded in the name of G. Mote Callander, Ontario. Authority to extract process and test market the sample was acquired under Sec. 52 of The Mining Act. R.S.O, 1990, Ch. M-14. Work was preformed by G. Mote and associates with technical assistance from Fudge & Associates.

The purpose of the program was to test market and confirm marketability of dimension stone from the property. In order to secure ongoing markets for the stone, potential customers needed to be convinced that the orebody was capable of producing a uniform, attractive landscape stone meeting their end-user expectation. Of specific importance is parallel jointing and subsequent amenability to splitting into a uniform product for a variety of end use applications.

## 2.0 Location and Access

The Jocko River Property is located 44.5 km north east of the City of North Bay via Highway 63 in the north east corner of Jocko Township, and 600 meters south and west of the Jocko River along a logging road.




Figure 2 Mining Claim S 1246599, Jocko Township

The Jocko River Property is comprised of 14 4 unit unpatented mining claim S 1246599 held 100% by G. Mote, Box 238, Callander, Ontario, POH 1HO. The claim is in good standing until August 25, 2005.

## 5.0 Previous Work

Between 1971 and 1973 G. Mote completed a stripping and sampling program on Mining Lease S290850, 250 meters north of current mining claim S 1246599. The 1971-73 programs focused on developing marketable flagstone. There is no other recorded work in the township.

# 6.0 General Geology


O.G.S. Map 2361 shows mining Claim S 1246599 to be underline by quartzo- feldspathic gneiss. An un-published report in 1991 by E. Bassa, Staff Geologist with the Ministry of Northern Development and Mines, Titled North Bay – Thorne Building Stone Inventory described the area as:

"The rocks are metamorphosed to a lower amphibolite facies and contain appreciable amounts of mica. The mica rich bands impart a strong somewhat variable foliation in the rock. This foliation commonly acts as a plane of weakness for splitting the stone....These rocks have been identified as middle Precambrian (Grenville) muscovite and quartzose gneisses.

Other minerals observed in the sample include biotie, feldspar and minor amounts of hematite. The stone is characterized by a distinctive olive green colour. Quality determining properties include; colour, abundance of mica, grain size, uniformity and joint spacing.

# 7.0 Work Program

The bulk sampling program was carried out under "Permission To Test Material" issued under Sec. 52(1) of the Mining Act, R.S.O. 1990. (See Appendix "A"). After clearing of merchantable timber under authority of M.N.R. Fuel-wood License F63966, shallow overburden was stripped using a Link Belt 4300 back hoe to expose bedrock. The back hoe was then used to selectively wedge and strip bedrock slabs along lines of parallel jointing. Selected blasting was used to loosen "tight areas" of the pit.






### **Typical Quarry Product**

623 Tonnes of stone were sorted, loaded and trucked to Callander Industries yard at 62 Park Street, Callander. Ontario for further splitting and loading onto pallets for shipment. Field work was completed during the period May 21, 2004 to September 31, 2004. Commencing in October 2004 selected samples were shipped for test marketing to locations in Ontario and Ohio.

## 8.0 Conclusions and Recommendations

Frost penetration of the top .2 meters resulted in cross fracturing of beds and permitted penetration of gangue materials along fracture planes resulting in less attractive stone. Future production should remove upper .2 meters as part of site preparation and prior to production.

Although some variation in jointing was noted and hence amenability to splitting this factor was not considered to be detrimental to production of a uniform product.

Test marketing of Bulk Sample confirmed that the olive green flag stone is a marketable product in demand in Ontario and U.S markets. The stone is uniform in appearance which will allow for production of a consistent product over many years.

Acquisition of a Category 11 or 12 Aggregate Permit is required prior to commencement of commercial production.

Subject to permitting, this property is ready for commercial production.

### **Re: Permission to Bulk Sample Mining Claim**

We represent Gary Mote in this matter.

We wish to apply for permission to obtain a bulk sample under Sec. 52 of the Mining Act, RS.O, 1990, Ch. M.14, from mining claim S 1246599 at the location shown on the attached map.

Shallow overburden will be stripped with a backhoe and stockpiled. The proposed area is under  $625 \text{ m}^2$ .

The sample will be composed of 1000 tonnes of micaceous silica thought to be suitable for production of flagstone. It will be removed and trucked to Callander Industries yard at 62 Park Street, Callander, Ontario, and Lot 22, Con. 23, North Himsworth Township. Selected "flagstone" stockpiled at these site will be test marketed in Canada and the United States.

### PERMISSION TO TEST MATERIAL

Under the authority of Subsection 52(1) of the Mining Act, R.S.O., 1990, Gary M. Mote is hereby granted permission to remove and test in-situ rock samples from the following site:

Mining claim S1246599, Jocko Township. The recorded claim holder being Gary M. Mote.

The sample shall consist of micaceous flagstone and the aggregate tonnage of rock removed is not to exceed 1000 tonnes. If applicable, all processing and testing shall be carried out off site. Under Subsection 52(4) of the Mining Act any proceeds above and beyond the eligible costs of stripping, removing, transporting, processing, marketing and testing said samples shall be escheated to the Crown and paid via a cheque made out to the Minister of Finance.

Further, this permission is conditional upon the claim holder, Gary M. Mote adhering to all applicable legislation, regulations and permit requirements. Following removal of the bulk sample, the site shall be left in a safe condition. Rehabilitation measures must be undertaken as outlined in Appendix A.

### APPENDIX A Permission to Test Materials – Gary M. Mote Claim S1246599, Jocko Township

#### Rehabilitation Requirements

With respect to this work the following rehabilitation measures shall be undertaken upon completion of removal of the sample. If the site proceeds to production the final rehabilitation of this test site shall be incorporated into the site plan covered by your Aggregate Permit as issued under the Aggregate Resources Act.

- Install proper signage at the entrance to the extraction site and to entrance of any test pit or quarry
- Block access road to the site
- Stripped topsoil and overburden shall be stockpiled for future rehabilitation.
- Recover stripped areas with overburden and topsoil
- All chemicals, oils; contaminated soil, temporary shelters, explosives and garbage to be removed from the site
- The site to be left in a safe condition
- Any pit wall that poses a safety or stability concern shall be closed out as per the *Mine Rehabilitation Code of Ontario*
- A fence may be required at the brow of any vertical rock face or pit wall following inspection
- Any rock piles of material left on site must be stabilized to the natural angle of repose and tested for AGP (acid generating potential). The Ministry shall be contacted prior to disposal of any AGP rock
- Monitor the site for measures implemented above





By Nipissing Forest Sustainable Forest Licence 542053 dated the 3rd day of July, 1996 (hereinafter referred to as the "SFL"), NFRM was granted by Her Majesty the Queen in Right of the Province of Ontario as represented by the Minister of Natural Resources (herein referred to as "the Crown"), the right to cut and remove all kinds and classes of timber on and from the area described in the said SFL (hereinafter referred to as "the SFL Area"), subject to the terms and conditions of the said SFL, and to the governing legislation and regulations of the Province of Ontario.

The Fuelwood User desires to cut and remove from a portion of the SFL Area (hereinafter referred to as "the Harvest Area) a quantity of wood fibre in the form of fuelwood and in order to facilitate this activity the Harvester wishes to obtain a licence (Overlapping Forest Resource Licence) as provided in Section 38 of the Crown Forest Sustainability Act (CFSA) with respect to the harvest area.

Pursuant to Section 38 (2) of the CFSA, the Parties wish to set out herein their agreement as to the terms and conditions under which NFRM is willing to grant to the Fuetwood User permission to cut and remove such wood fibre from the Harvest Area. The Parties agree as follows:

- Fuelwood Species, Volume: NFRM grants to the Fuelwood User the right to cut the following maximum 1. cubic metres of fuelwood from the harvest area:

This area is either a designated public fuelwood area where the species may be harvested or an area where other unmerchantable material can be obtained. This is specified on the map which forms "Appendix A".
  - Charges Payable to NFRM: No charges are payable by the Fuelwood User to NFRM with respect to this Agreement to harvest in a designated fuelwood area or for obtaining unmerchantable material in the area shown in "Appendix A".
