Name: Claim 4205130 Gold project

Claim: 4205130, held by Alex Glatz of Dryden

Access: Located in Audrey Twp., Lot 2 Con II about 12 kilometres SW of Dryden, it can be reached via Hwy. 594 and Hwy. 502.

History: The claim is located at the west end of the old "Dryden Gold Fields" where many shafts have been sunk more than one hundred years ago.

Target: Gold

Geology: Regional – The area south of Dryden is underlain by the Lower Wabigoon Volcanics (Trowel et al 1980).

The project area exhibits rocks of felsic and intermediate composition which are intruded by at least two QFP dikes.

Prospecting:

Recent prospecting consisted mainly of mapping the mineralized tuff and to find new rock outcroppings. It was found that the volcanic rock strike in an ENE direction whereas the QFP strike in a NW direction. The tuff formation carries sulfide along the shear planes. The sulfide consists mainly of cubed pyrite.

The amount of sulfide of sulfide has no relation to the gold content. The limited sampling suggests that the gold is related to quartz or silicified zones rather than the softer carbonrich rock.

Conclusion and recommendations

Further work in the form of mechanical stripping to expose the boundary of the quartz-stockwork is recommended.
