

REPORT ON CAMPBELL, SILVER, FISHMAN ET AL CLAIMS EAST BULL LAKE AREA TOWNSHIP 123 ALGOMA DISTRICT

LOCATION AND ACCESSIBILITY

This property comprises twenty-seven contiguous mining claims (Numbers S-53828 to S-53854, inclusively. Plus two patented claims numbered S-30128 and S-31225. These claims form an east-west rectangular block in the northwest quarter of Township 123, of Algoma District.

A good motor road crosses the western portion of the claims, about 22 miles north of the Village of Massey, which is located on the C.P.R. about 60 miles west of Sudbury.

TOPOGRAPHY

The terrain is very rough, most of the area being traversed by steep ridges. Numerous outcroppings of rock occur on the property, but most of the area is covered with drift and overgrown with second growth trees and brush.

Water for any operation is available from East Bull Lake which lies at the north-west corner of the property, or from the Aux Sables River which flows south to the east of the property.

A forestry Station of the Ontario Department of Lands and Forests is located on the road at the east side of the lake. No other buildings were noted in the area.

GENERAL GEOLOGY

The four Townships, 123, 124, 130 and 131, make up what is called the East Bull Lake Area. This section was mapped by the Geological Branch of the Department of Mines of Ontario in 1942. The resulting map and report, Volume LII, Part VI, 1943, show that the area is underlain by, mainly Algoman Granite, Keewatin lavas and Haileyburian gabbro. East of the centre of the area there are fairly extensive masses of Huronian quartzite and conglomerate and Keweenawan quartz diabase. Comparatively small amounts of Keweenawan olivine diabase and granite of killarney age were also located in the central region.

The Department Geologists noted that no major faulting was located, but cliff faces appeared to indicate such, trending east-west and northeast-southwest.

GEOLOGY OF THE PROPERTY

All of the rocks that are exposed on the twenty-nine claims that comprise this property are Haileyburian in age and are anorthosites, amphibolites and norites of the East Bull Lake gabbre or hybrid varies of these derived from the intrusions of the Killarney granite.

In minor shears and contact zones in these rocks, massive sulphides occur in the form of pyrrhotite pyrite, chalco-pyrite, and some magnetite. On the outcrops these mineralized spots are easily located due to the oxidized stain which covers them. By trenching and drilling and blasting numerous small isolated replacement zones of these sulphides have been explored.

These sulphide areas will attract the dip needle and E. S. Moore reports in the Department of Mines Geological Report that he was able to locate several additional areas where the rock is not exposed. The present owners supplied the writer with a map of a magnetometer survey which was carried out on the claims several years ago. This survey indicated an anomoly across three claims and trending over the exposed areas of sulphides, bearing about N. 70° E.

It is believed that the sulphides, which carry scattered values in nickel and copper, were derived from the Killarney granite.

HISTORY AND EXPLORATION

The claims of this group, particularly those with the showings, have been prospected over and staked and restaked by numerous persons over a period of many years. Many feet of surface trenching has been dug and on and adjacent to most of sulphide bodies holes have been blasted into the rock, all of this work having been done by handsteel.

Some of this work was done by Mr. Samuel Rossac who had claims S31225 and S30128 patented, or the required work for such completed and a lease obtained, patents not being granted in the Mississagi Provincial Forest Reserve. Mr. Belanger of Timmins, and Mr. R. M. Ritchie of Massey, jointly held some of these claims at one time and carried out a considerable amount of surface work.

Samples have been taken from the showings by numerous parties, all of the records show values in copper and most of them values in nickel as well as copper.

Mr. Lloyd Campbell one of the present owners, took samples from various exposures and obtained the following results from Swastika Laboratories Limited:

The map of the magnetometer survey, provided by Mr. Rossac, showed assay results on the various showings the best being 1.65% in copper and 0.95% in nickel. The nickel assay coming from a pit in the north-east corner of claim No. S53844 and the high copper assay from a pit in the west central part of claim No. S53845. Other records show values in nickel up to 8.81%.

The writer took two grab samples from the best looking sulphide showings in the north west portion of claim No. S53837. The following results were obtained.

The first of the above samples was taken from the stained surface of the pit. ond sample was taken from the fresh massive sulphide material below the stained gossan. Little if any conclusions can be drawn from the results, regarding a concentration in the gossan.

CONCLUSIONS AND RECOMMENDATIONS:

As further exploration by surface trenching and drilling and blasting would be very expensive and the information gained very limited for the cost, the logical procedure would be to carry out a diamond drilling exploration program.

- This should be laid out with two objects in mind. Explore for the downward extension of the surface showings and the possibilities of larger masses of the sulphide concentrates at depth.
- Explore for main shear zones which should be correspondingly mineralized as the minor shears which are exposed. The old stream beds which now appear as gullies traversing the country side and at present filled with drift, sections of which are quite swampy, could be covering planes of weakness in the form of shears or compressions creeks.

Geologically this group of claims make up a very favourable looking prospect. values in copper and nickel extend along a definite zone of minor shearing for a distance of over a mile. The host rock is similar to that of Sud bury mining area and structural features indicate that further exploration is warranted.
