He was originally looking for the quartz stockwork as show on Map 1953-03.

Project Location Sothman Township Porcupine Mining Divison Claim 4259233 1 unit

The property is accessed via the Grassy Lake Road from its starting point at Highway 560, approximately 6 km east of the hamlet of Shining Tree. Following the Grassy Lake Road north for approximately 50 km to a secondary road which leads west to a boat landing on the Grassy River near Sinclair Lake. A boat is required to reach the claim 5km westerly on the Grassy River to the northeast corner of Sinclair Lake.

General Geology- The area of Sothman Township is which the claim lies are all Pre-Cambrian age. Consisting of folded volcanics and sedimentary horizons cut by irregular shaped bodies of basic intrusives and regular shaped dikes of predominately north striking diabase. Part of the claim is covered by younger flat-lying Cobalt series sediments.

The property is on the east shore of Sinclair Lake which supports small islands of peridotites that are soft, black and appear serpentine rich. The west shore of Sinclair Lake is granite. The property is underlain by mafic volcanics. It exhibits some pillow structures and dioritic rocks that are lightly colored with flecks of pink and white feldspar. Pyrite is common in these rocks.

A series of detailed works have been done the area adjacent to the claim. Directly on the claim work was performed by Miami General Development Mines Limited in 1948. The work is outlined in assessment reports 41P14SW0008 and 41P14SE0046. Miami General covers two properties in these reports- the Miami Group and the Hanson Group of which the claim lies in the Hanson Group. Miami performed geological mapping and Iso-dynamic contours of vertical Intensities. These reports mention that gold was first found on the property by an Indian trapper during WW1. These reports also discuss finding "colors" while panning.

OGS produced a geology map for Sothman Township (Map M1953-03)


In 1969, Albert Decker drilled 4 very short holes on the north boundary of the claim but does not include any assays in the drill logs.

An AEM survey was done by MNDM in 1990. This survey identified 2 conductors on the present claim.

In 2004, Mustang Minerals flew a survey over the adjacent claim in Nursey Twp (AFRI 41P14SW2005) and the mapping of the survey shows a 6 and a 5 channel conductor anomaly on the current claim.

In 2008, Ra Resources, under option, performed a VLF and Magnetometer survey over the area of the 2 conductors.
