This report will discuss the claim line re-furbishing performed by D. Gibson and J. Savard on mining claims 4271487 and 4257097 in October 2014. Within McAuslan Township, Sudbury Mining Division for Nature Stone Corporation, client # 401198.

Schedule of Events

On Oct 22, 2013 D. Gibson and J. Savard arrived at the Naturestone Quarry facilities on Reynolds Lake in McAuslan Twp.

On Oct 22, 2014, commenced refurbishing of the claim lines along claims 4271847 and 4257097.

On Oct 27, 2014 the refurbishing of the claim lines was completed and D. Gibson and J. Savard departed from the Naturestone Quarry Facilities on Reynolds Lake.

Personnel

D. Gibson and J. Savard were the personnel involved in performing the re-furbishing, re-cutting and re-marking of the claim boundaries.

Property

The Naturestone claims 4271487 and 4257097 are located approximately 86 km north-east of the city of North Bay, Ontario. Within the south-central portion of McAuslan Township, contiguous to other patented and leased mining claims in the Reynolds Lake area. See Lines Refurbishing map and Claim Map.

Access

Access to the property was by way of highway and well maintained dirt road. To access the property, travel east along Hwy 63 from the city of North Bay, Ontario for approximately 57 km to the McConnell Lake Road turnoff. Then travel north along the McConnell lake road for approximately 24.5 km to the Diver Lake Road. Then turn west and travel 3 km along the Diver Lake Road to the Reynolds Lake Road, then 1.5km down the Reynolds Lake Road to the gates of the Naturestone Quarry.

The mining claims can be accessed from within the quarry property along a private established road. See Claim Map.

Purpose Of the Work

The purpose for the refurbishing of the claim boundaries along claims 4271487 and 4257097, was the lines were unidentifiable in the field, due to the large amount of blow down that had taken place over the past couple of years.

Discussions

The re-furbishing of the boundaries commenced the afternoon of October 22, 2014 and was completed on October 27, 2014.

The claim lines of claims 4271847 and 4257097 were re-established and re-marked along the existing claim boundaries using chainsaw and flagging tape. The blow-down was cut out along the claim lines and trees were blazed using chainsaw. Lines were then flagged with orange flagging tape to make them further identifiable. A total of 3.492kilomters of claim boundaries were re-furbished by chainsaw along claims 4271847 and 4257097.

Accommodations and meals were provided at the Naturestone quarry camp facilities, located on the Patented and Lease Claims on the north side of Reynolds Lake.

Conclusion

The re-furbishing of the boundaries took longer than anticipated due to the large amount of blow-down encountered along the lines and also due to the heavy rains that fell during that time period. Yet overall the program was completed in a timely and efficient manner.

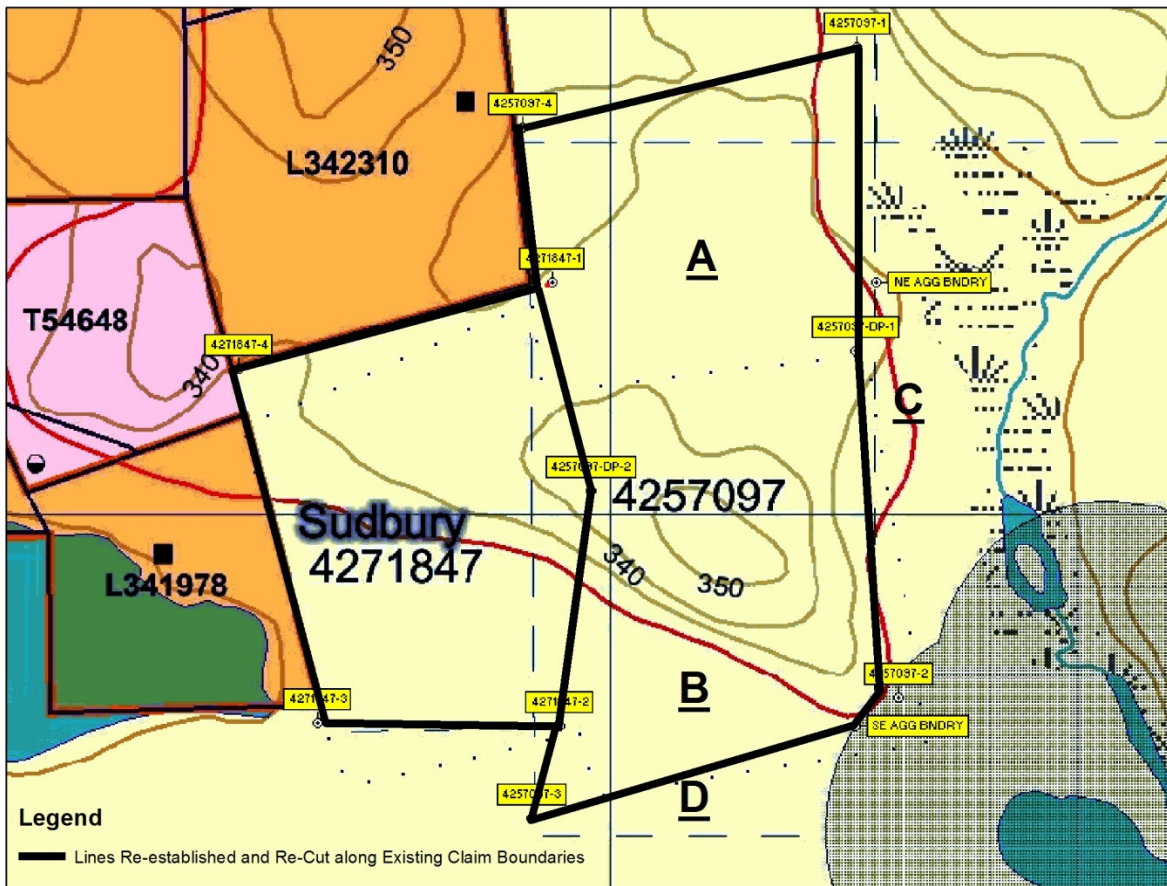

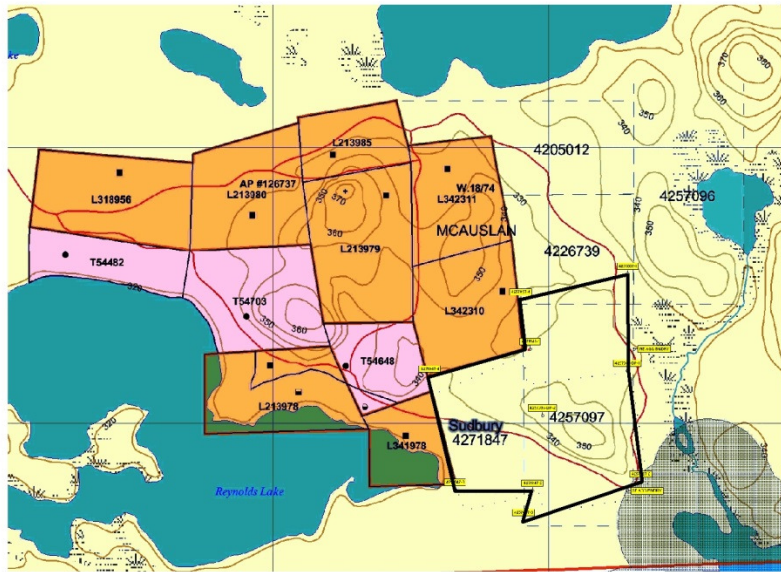
