# 1. SURVEY DETAILS

#### 1.1 PROJECT NAME

This project is known as the Bradette Property.

#### 1.3 LOCATION

The Bradette Property is located approximately 165km north of Larder Lake, Ontario. Mining claims 4245988, 4245989 and 4245990 is located in Bradette Township within the Larder Lake Mining Division.




Figure 1: Location of the Bradette Property



# 1.4 Access

The Bradette property was accessed by helicopter from the Expedition Helicopter Base in Cochrane, Ontario.

#### 1.5 GENERAL GEOLOGY

A reconnaissance geological survey has been made in the area by R. Thompson, and published in the "Geology of the Burntbush River Area" - Ontario Department of Mines Forty-fifth Annual Report (1936) part VI, pp 49-70. Most of the outcrops were mapped along the drainage systems, and no outcrops were mapped within seven miles of the property. From his mapping to the south and west, there is a major Keewatin belt composed of acidic to basic volcanics with associated schists and gneisses which have an east-west trend. The rock formations have a vertical to steep dips. Granitic intrusive batholithic rocks lies on both sides of this Keewatin volcanic belt.

From an interpretation of the airborne magnetic maps the north contact between the granitic intrusive rocks to the north and the Keewatin basic volcanic belt lies approximately 2 miles south of Tonkin Lake. This magnetic high belt which could represent a N75E trending basic volcanic might also represent a more basic intrusive, such as diabase, gabbro or serpentinite but these would still be related to the same Keewatin belt. The isomagnetic lines trend NNE in the region around Tonkin Lake and are of lower intensity.




Figure 2: Boundaries Rehabilitated of Mining Claim
