KM 30.4 KM YOU WILL SEE FOREST ACCESS ROAD ON THE RIGHT. CONTINUE ON HYY 63

KM 31.5 KM TURN RIGHT ON ROAD TO TWENTY MINUTE LAKE AND INDIAN LAKE.

AS YOU DRIVE DOWN ROAD YOU WILL SEE A LARGE GRAVEL PIT ON YOUR LEFT. KEEP DRIVING

A SHORT DISTANCE THERE IS A ROAD ON YOUR LEFT. A SHORT DISTANCE THERE IS A VERY SHORT ROAD

GO PAST IT AND TAKE THE NEXT ROAD ON YOUR LEFT. DRIVE DOWN THAT ROAD KEEPING TO THE RIGHT YOU WILL REACH A LARGE CLEARING. FROM WHERE YOU PARK GO STRAIGHT AHEAD, A ATV TRAIL THAT IS WELL FLAGGED WILL BRING YOU RIGHT TO THE NORTH END OF TRENCH.

ASSESSMENT WORK ON CLAIM #1197239

21 MAY 2016. 9:00 AM TO 4PM. 14 MHRS 72 KLMS.

GEORGE KEALEY AND JAMES CRIPPS WENT OUT TO MINERAL CLAIM.

WE SET UP OUR SIFTING SCREENS, THAT OUR ROPES BROKE DURING THE WINTER. THEN WE TOOK SOME OVERBURDON OFF THE NORTH END OF TRENCH. JAMES SIFTED THROUGH THE OVERBURDON AND THEN WE LOOKED FOR CRACKS ON THE EDGE OF THE TRENCH AND DROVE RAILWAY SPIKES INTO THEM WITH A HAND SLEDGE. WHEN WE GOT THE ROCK OPEN WE USED A SCALING BAR TO PRY THE SLABS OFF. WE DID FIND SOME AMETHYST AND QUARTZ CRYSTALS BUT THEY WERE SMALL.

28 MAY 2016. 9:30 AM TO 4:30 PM. 14 MHRS 72 KLMS

GEORGE KEALEY AND JAMES CRIPPS WENT OUT TO MINERAL CLAIM.

WE MOVED SOME OF THE ROCKS THAT WERE BLASTED YEARS AGO BY OTHER PEOPLE THAT HAD THE CLAIM ON THE HILL THAT GOES DOWN TO THE BEAVER DAM. SOME OF THE ROCKS DID HAVE SOME AMETHYST AND QUARTZ ON THEM. MOST OF THE CRYSTALS WERE DAMAGED. THEN WE TOOK SOME SLABS OFF THE NORTH END OF THE TRENCH. WE DID FIND SOME HEMATITE COVERED CRYSTALS.

25 JUNE 2016. 9:30AM TO 4:30PM 14 MHRS 72 KLMS

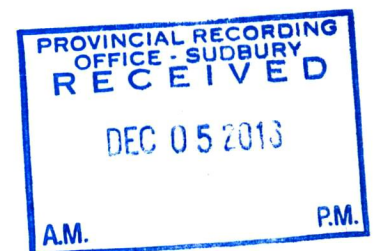
JAMES AND GEORGE REMOVED SOME OVERBURDON ON THE NORTH WEST SIDE OF THE TRENCH AND THEN WE USED OUT RAIL SPIKES AND SCALING BAR AND GOT A FEW SLABS OFF. THERE WERE SOME NICE AMETHYST PIECES. AND SOME JUST QUARTS WITH SOME COATED AMETHYST.

09 JULY 2016. 900 AM TO 5:00 PM. 16 MHRS 72 KLMS

JAMES AND GEORGE WENT INTO THE MINERAL CLAIM AND TOOK SOME OVERBURDON OFF THE SOUTH EAST SIDE OF TRENCH AND THEN WE TOOK A FEW SLABS OFF USING RAIL SPIKES, SLEDGE AND SCALING BAR. WE MANAGED TO GET SOME NICE AMETHYST IN ONE SLAB AND A FEW SMALL ONES OFF THE SECOND SLAB.

23 JULY 2016. 10:00AM TO 4:00PM. 12MHRS 72KLMS

JAMES AND I WENT INTO OUR MINERAL CLAIM AND TOOK SOME MORE OVERBURDON OFF THE SOUTH WEST END OF THE TRENCH WE TOOK TWO GOOD SIZED SLABS USING RAIL SPIKES A SLEDGE AND SCALING BAR. BUT THERE WERE NO CRYSTALS THERE. BEFORE WE LEFT WE DID SOME SCREENING IN THE WEST SIDE IN THE MIDDLE OF THE TRENCH. WE GOT A FEW NICE AMETHYST CRYSTALS.

JAMES AND I WENT OUT TO OUR MINERAL CLAIM AND SPENT THE MOST OF OUR TIME SHOVELING THE EARTH IN THE WEST SIDE OF THE TRENCH INTO THE SCREEN WE DID FIND SOME SINGLE CRYSTALS OF QUARTZ AND AMETHYST. THEN WE MOVED SOME OF THE ROCKS AT THE BOTTOM OF THE CLIFF ON THE WEST SIDE OF THE TRENCH.

27 AUG 2016. 10:00 TO 4:00. 12 MHRS 72 KLMS.

JAMES AND GEORGE WENT OUT TO OUR MINERAL CLAIM AND REMOVED QUITE A FEW ROCKS FROM THE BOTTOM OF THE TRENCH. THEN WE DID SOME SCREENING. THEN WE REMOVED SOME OVERBURDON AND USING RAIL SPIKES AND SCALING BAR. WE GOT A COUPLE OF PIECES OFF WEST SIDE OF THE TRENCH.

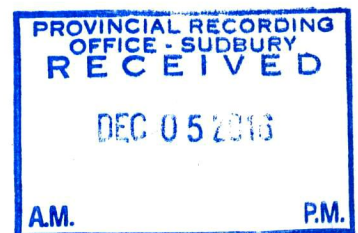
17 SEPT 2016. 8:00 TO 2:00. 12 MHRS. 72 KLMS.

JAMES AND GEORGE WENT TO THE CLAIM AND REMOVED SOME MORE ROCKS FROM THE BOTTON OF THE TRENCH. IT IS WIDE OPEN IN THE SOUTH END OF THE TRENCH. THEN WE TOOK SOME OF THE OVERBURDON OFF THE SOUTH EAST SIDE OF TRENCH.

OCT 9 2016. 9:00 TO 4:00. 14 MHRS. 72 KLMS.

WHEN JAMES AND JIM WENT INTO THE CLAIM WE FOUND THAT THE HUNTERS HAD PUT SOME STORE BOUGHT SIGNS ON THE TREES SAYING THAT THERE ARE HUNTERS IN THE AREA AND THEY HAD WIDENED THE TRAIL IN. JAMES AND I WENT INTO THE CLAIM. WE DIDNT SEE AND HUNTERS SO WE DID SOME ROCK SPLITING ON THE NORTH WEST SIDE OF THE TRENCH. WE DID GET SOME CRYSTALS BUT THEY HAD GROWN INTO EACH OTHER.

THERE IS A BEAVER POND JUST BELOW AND TO THE WEST OF THE CLAIM. SO WE DECIDED TO STAY AWAY WHILE THEY ARE HUNTING.
