

#### Description. Location and Access

Ontario Mining Claim TB4269399 is composed of a single unit located in the Tartan Lake Area. G-plan map G-2706. The claim is approximately 27 acres in size, and is of an irregular diamond-shaped pattern. This claim was staked by the author and was required to follow the pre-existing boundary of the previously leased and surveyed claim. The claim was originally staked very poorly by an amateur, which showed up in the subsequent land survey results. This claim is accessed by a seasonal logging road, known as the Magone Road, 10 miles N. of Hwy. 11-17, which heads E. off of Hwy.528.

The previous owners created a driveway from which to enter the old quarry area from the Magone Road.

### Type of Work Performed

Physical work consisted of prospecting and manual stripping over quartz veins which were discovered in 2014. 3 areas were stripped and washed. One was stripped to reveal a wide stockwork of amethyst veins. The other two areas were stripped to determine the veins' possible continuance. Tools used were a chainsaw, axe, branch lopping tools, water pump, shovels, miner's picks, scaling bar, etc. The three stripped areas are now (B)2m.x 8m., (A)4m. x 6m. and (C)2m. x 5m. in size. Overburden removed consisted of shrubbery, trees, and up to two feet of unconsolidated glacial till and moss that obscure these amethyst veins.

## Summary of Work and Related Costs

Work Days, 42 days @ \$150/day = \$6,300

Transport, 100km./day x 17 days x \$.40/km. = \$680

Gas and oil for water pump = \$50
