The program of work consisted of stripping moss from a cliff face located immediately above a quartz vein and taking a total of 6 grab samples from the exposed vein and sending them off to the lab, to be assayed for gold and silver. The width of the quartz vein is approx. 13 cm and runs for 8 meters. The bull quartz vein itself contained no sulphides with only minor amounts in a few places in the adjacent host rock where some bleaching was noted. Stewart A. Ferguson in Report No 58-Geology and Ore deposits of Tisdale Township mapped the host rock as a flow top breccia of met volcanic basalt origin.




Equipment used consisted of a truck to travel to and from the property, a GPS unit, compass, axe, and hammer and pick.


