## Introduction

The Whitney TWP SP Property is described as the SE ¼ of the N ½ of Lot 9, Concession 4, Whitney Township, Porcupine Mining Division. It is comprised of one single unit claim numbered 4271151 occupying 16 hectares in area. The claim location is immediately north of the Porcupine-Destor Fault Zone and proximally to the south of the Dome Fault Zone. Underlying strata is inferred from geophysical data to be metamorphosed ultramafic rocks.

## Location and Access

The Whitney Twp SP Property is located north of the town of Porcupine. It is road accessible by travelling north on Gervais Street North off provincial highway 101 East. The property is transected by the Porcupine River and the northwest half of the property is most easily accessed by boat from the southeast side.

## Prospecting Program

On May 22, 2016, Randall Salo, Jacques Robert and Shelly Moretti traversed the claim on foot using geotul grub hoe's and a steel rod in an effort to discover bedrock or subcrop close to surface. Approximately 4.7 km of traversing was carried out (see appended map). Investigation depths did not exceed 30 cm. The northwest part of the property was accessed by boat across the Porcupine River.

## Program Results

No outcrop was discovered on claim 4271151. Much of the claim is characterized by low-lying topography except for the north-west part where a higher topographic poplar treed area exists.

## Recommendations

Given the close proximity north of the Porcupine-Destor Fault Zone and inferred underlying metamorphosed ultramafic rocks, ground geophysical ground geochemical surveying is recommended along with diamond drilling to test the underlying bedrock for possible auriferous zones of interest.
