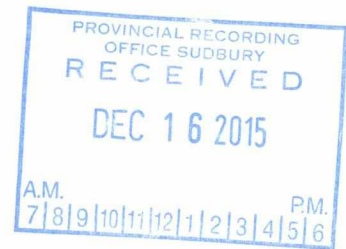

### Report on activity

The work being reported is for Claim #TB 4268315 located in Laurie Township. It is located approximately 70 kilometers west of Thunder Bay, Ontario. It is a two claim block.

The claim was staked on Dec 20<sup>th</sup>.2011 by Jason Shaver on behalf of Bill Snell. On November 8, 2013 the claim was transferred to William Murray Yahn.

On November 2<sup>nd</sup>, 2015 we traversed the claim to locate targets for ongoing assessment and took samples for assays

The Shabaqua area is an active gold zone. Much of the areas surrounding my claim have been staked with good showings for Gold. Drilling activity has been intense to the southwest.

### Work completed and results of assays taken

#### November 2, 2015:

Bill Yahn: truck, utility trailer, ATV, rock saw, chain saw, other prospecting tools, Terry Yahn: car, GPS, Compass and prospecting tools.

On the morning of November 2<sup>nd</sup>, 2015 we traversed the claim looking for areas of interest. We used the ATV for travelling along the river path until halted by heavy overgrowth and then continued on foot. The area covered was heading east along the north side of the Matawan River. We continued to work our way to the eastern boundary of the claim.

To our left (north) the ground rose quickly up a mountain. Further east the ground rose again as we moved away from the river. We worked our way along until we found exposed ridges and samples were taken. We checked creek beds, tree wells and outcrops for acceptable samples.

That afternoon we walked further north and then back to our ATV.

#### Sample #447249 (certificate attached)

The sample was taken from an exposed rock face which we scraped clear of moss and debris. Our indicated waypoint was #527. The rock type is light brown to dark grey

**Rhyolite with a high quartz content but no Pyrite present.**

**Assay results show no gold, and low in other base metals. Picture provided.**



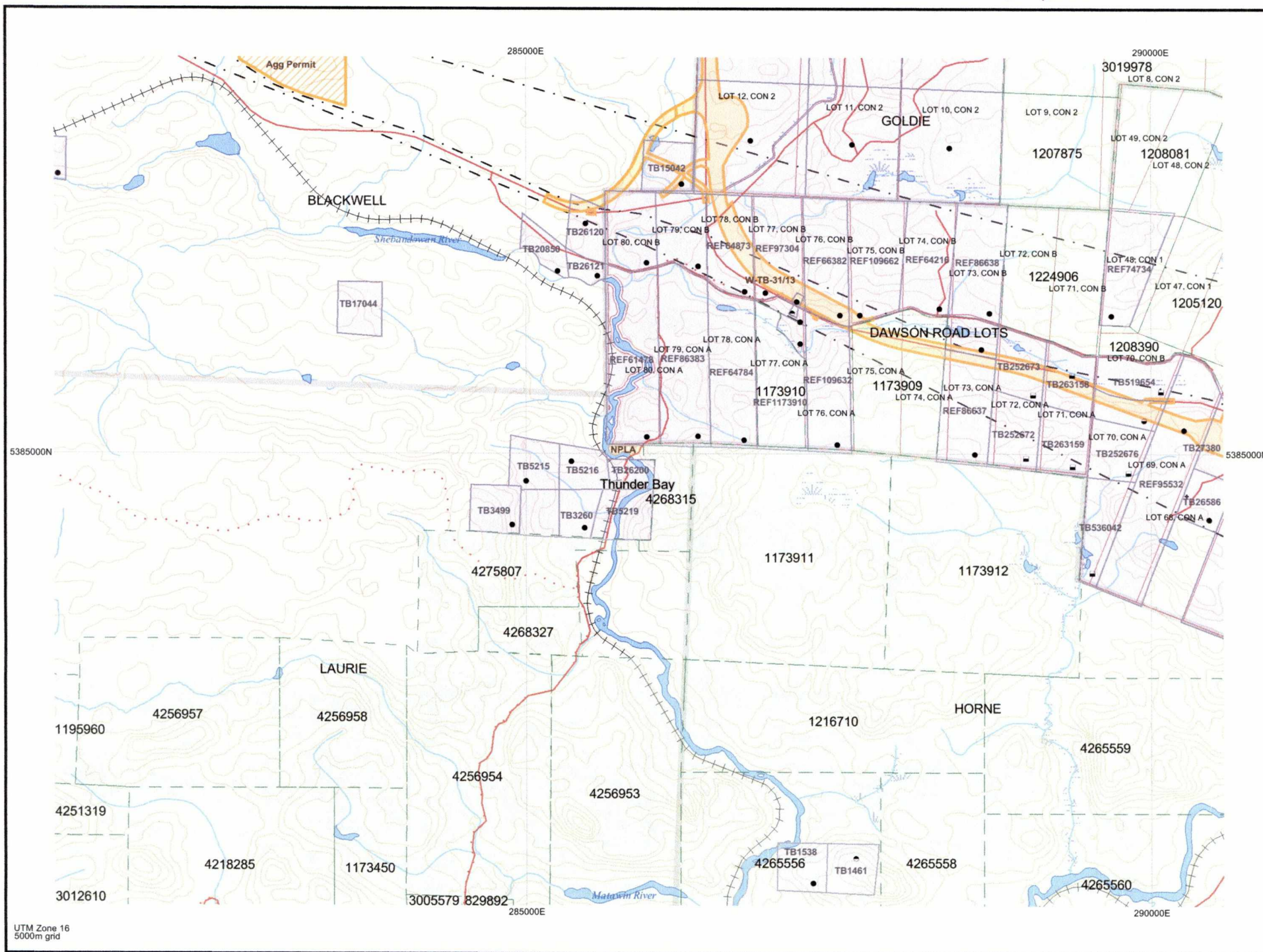

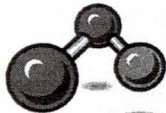
