Report on activity

The work being reported is for Claim #TB 4268315 located in Laurie Township. It is located approximately 70 kilometers west of Thunder Bay, Ontario. It is a two claim block with a second claim to the southwest #TB 4268327. On September 23rd.2014, I visited both claims and have split the expenses on the respective assessment reports.

The claim was staked on Dec 20th.2011 by Jason Shaver on behalf of Bill Snell. On November 8, 2013 the claim was transferred to William Murray Yahn. On November 12th I performed georeferencing work on this claim (W1340.02733) as my assessment work for last year.

This fall I revisited the claim to begin regular assessment work. Initially it was to transverse the area to locate targets . This was started on Sept 23rd 2014

The Shabaqua area is an active gold zone. Much of the areas surrounding my claim have been staked with good showings for Gold. Drilling activity has been intense to the southwest.

Work completed and results of assays taken

September 23/14:

Bill Yahn: one truck, utility trailer, ATV, rock saw, chain saw, other tools

On the morning of Sept 23rd I traversed the claim looking for areas of interest. I used an ATV for travelling along the road and paths. Once off road I found the access limited and continued on foot to survey more of the claim. The area covered was heading east along the north shore of the river. My plan was to work my way to the number one corner of the claim. After a short distance I had to abandon the ATV and proceed on foot. I ventured to the northeast and up the backside of the mountain. There is shallow overburden and outcrops higher up.

September 27/14:

Bill Yahn / Terry Yahn: two vehicles (one Jeep, one truck with utility trailer), ATV, rock saw, chain saw, other tools and supplies.

On Sept 27th. 2014, I returned to the area, along with an assistant, to traverse the area again north of the river. From an access road, we began on an old path heading east

that led along a riverbank to where the ATV got to earlier. We had to clear the overgrowth in several areas in order to progress from that point. To our left (north) the ground rose quickly up a mountain. We worked our way along until we found an area that we hoped would give us access to the mountain from the southeast but were unsuccessful.

That afternoon we walked the area and took surface samples using a rock saw.

Assay results listed as follows:

Sample #447240 (certificate attached)

The sample was taken within meters of the #4 Corner Post, from an exposed rock face about 20 meters off the trail. The rock type is light brown to dark grey Rhyolite with Pyrite present.

Assay results show no gold, and low in Copper, Nickle and Zinc. Picture provided.

Sample #447241 (certificate attached)

The sample was taken from an exposed rock face 4 meters from #447240 where the rock had more quartz and mineralization. The rock type is light brown to dark grey Rhyolite with Pyrite present. Full assay showing no gold, 6.03% Aluminum, 4.01% Calcium, 6.97% Iron and 4.06% Magnesium. Picture provided.

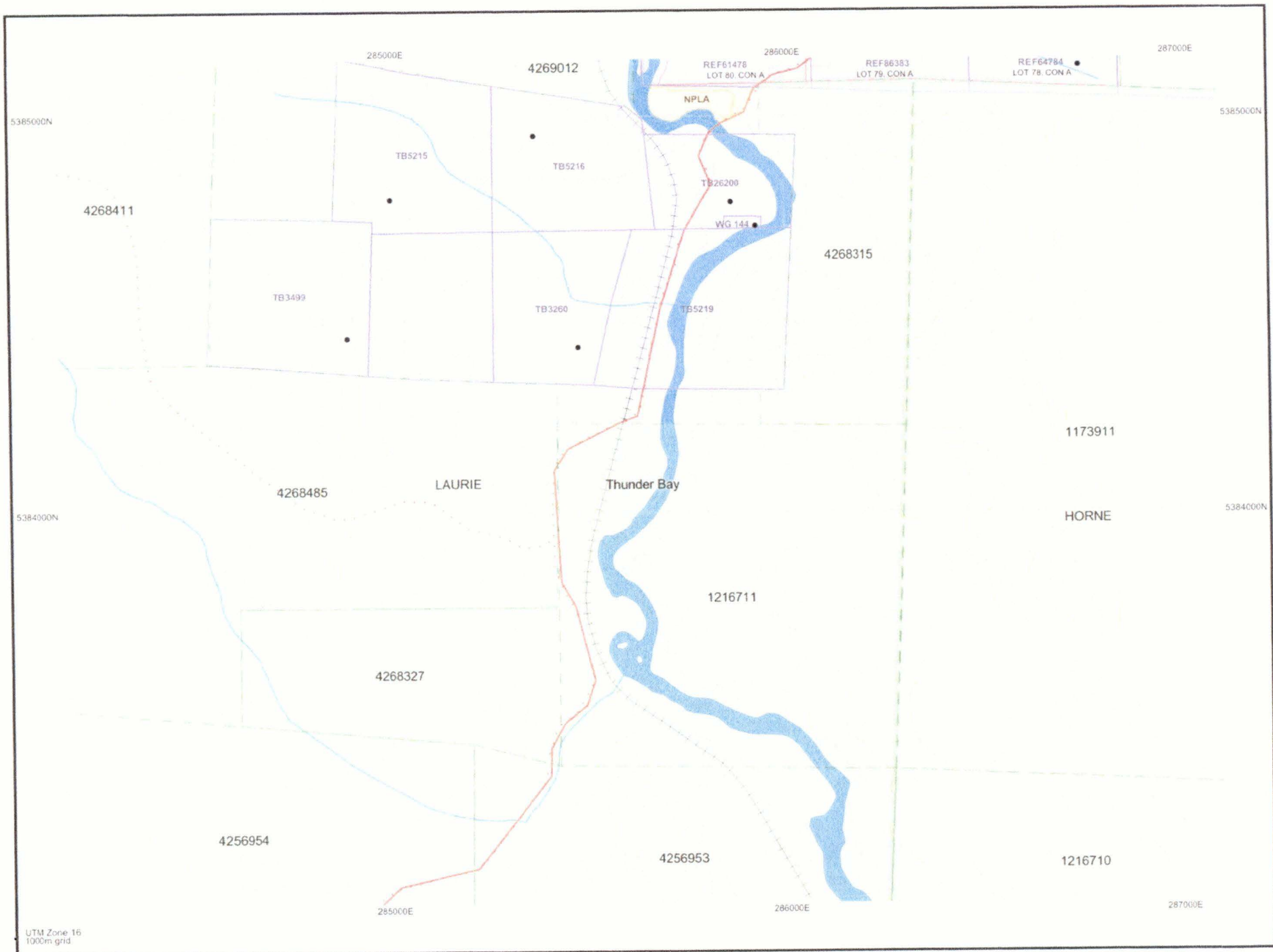
We know of the potential for gold in the Shabaqua area. However the previous owner of the claim did not sample the claim leaving us to base our plans on what is happening in the immediate area.
