

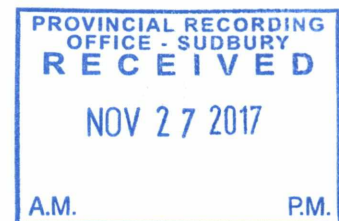

INTRODUCTION

Trip was made to the Bryan Et Al Group property in the summer of 2017 (July 25 to August 4) to obtain required GeoReferencing data, to re-cut claim lines on parts of all claims and to clear access road of fallen trees. All work was performed by Bernard J. Bryan. Georeferencing Technical Report was submitted and approved August 2017.

LOCATION

The Bryan Et Al Group of claims is located in the southwest corner of Chester Township in the Porcupine Mining Division of Ontario, approximately half way between Timmins and Sudbury and 480 kilometers from my home in Elmvale, Ontario

ACCESS

Access to the claims is via a 4.5 kilometer bush road running north from a turnoff on the Sultan road 6 Kilometers west of highway 144 at the junction with highway 580.

PROPERTY AND OWNERSHIP

Work was done on the access road to and on all Nine Claims: 1094717, 1094718, 1094719, 1094720, 1094721, 1094722, 1094723, 1094724 and 1191435.

DESCRIPTION OF WORK DONE

July 25, Travel of 480 kilometers to property from Elmvale, Ontario via personal pickup truck was done. Campsite preparation was also done this day.

July 26, one half day was spent clearing access road of fallen trees.

July 27, one and a quarter kilometers of re-cutting of claim lines was done along the Southeast part of claim 1094724, along the South claim line of 1094721 and along the South claim line of 1094718.

July 31, one and a quarter kilometers of re-cutting of claim lines was done along the North claim line of 1094717, along the North claim line of 1094720 and along the North claim line of 1094723.

August 1, one and a quarter kilometer of re-cutting of claim lines was done along the Northwest claim line of 1191435, along the North claim line of 1094719 and along the North claim line of 1094722.

August 2, one and a quarter kilometers of re-cutting of claim lines was done along the Northwest claim line of 1094721, along the North claim line 1094724, along the Northeast claim line of 1094721 and along the Northwest claim line of 1094718

August 3, one half kilometer of re-cutting of claim lines was done along the Southwest claim line of 1094724, and along the West claim line of 1094724

August 4, Campsite teardown and 480 kilometers of travel back to Elmvale, Ontario.

140 Kilometers of travel was done from Property to Watershed Restaurant during days spent at property.
