Summary

This claim was staked because of its MDI icon depicting a mineral occurrence within the block. At that time much of the township to the north, west and south were open. Since that time all land within the township has been staked and companies such as Central Timmins Exploration Corporation and International Explorers and Prospectors have snapped up the surrounding ground with an eye to finding the next VMS deposit in the area. To the west within the township is located the past producing Genex mine and still within the township to the north, the past producing Jamieson Mine.

Access to the claim is adequately provided as the Kamiscotia Road which branches north off of highway 101 west of Timmins conveniently bisects the claim. Most of the outcrop lies within two hundred metres of the road on the east side. The west side of the highway has been logged but seems to be devoid of outcrop.

Work on the claim consisted of prospecting the outcrops on four different days by myself. A total of ten (10) samples were collected from our first round of prospecting (tag #'s 257041-257050) in September of 2016. These were submitted on the 13th of February 2016 to Expert Laboratory in Rouyn-Noranda for assaying of Ag, Au, Cu and Zn. The results were disappointing with only one showing any Au – sample 257041 assayed 6 ppb. No samples assayed for any Ag. Cu assays fell between 20 and 60 ppm, while Zn results varied between 69 and 114 ppm. The certificate of analysis can be found at the end of this report.

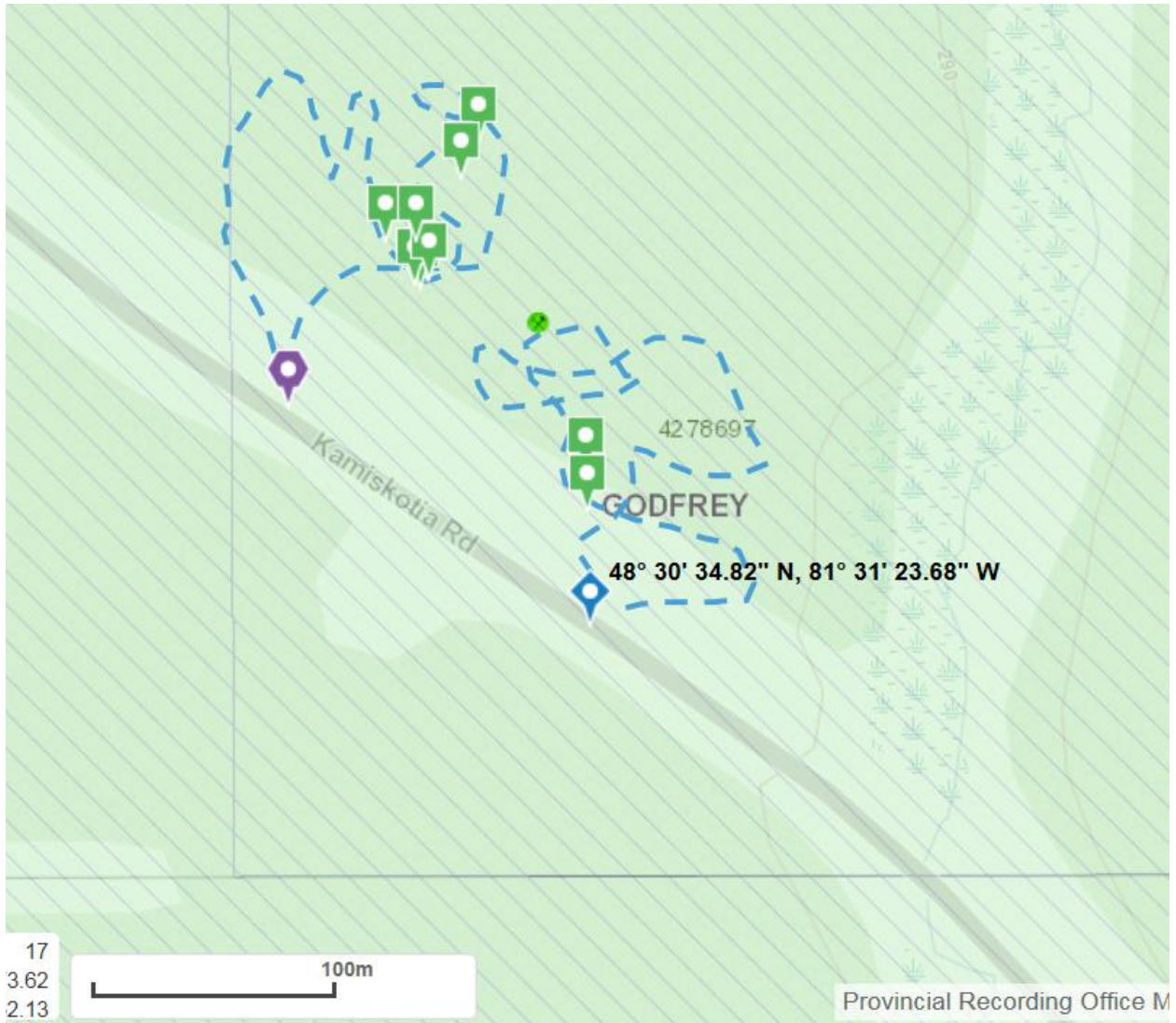

I did not get out to the prospect again until the fall of 2017. This time eleven samples were collected (tag #'s 131041-131051). These samples have not yet been submitted to the lab. A further traverse of the property is planned for the spring of this year (2019) to confirm whether or not any outcrop lies closer along the west bank of the river, and to collect any further interesting rock specimens.

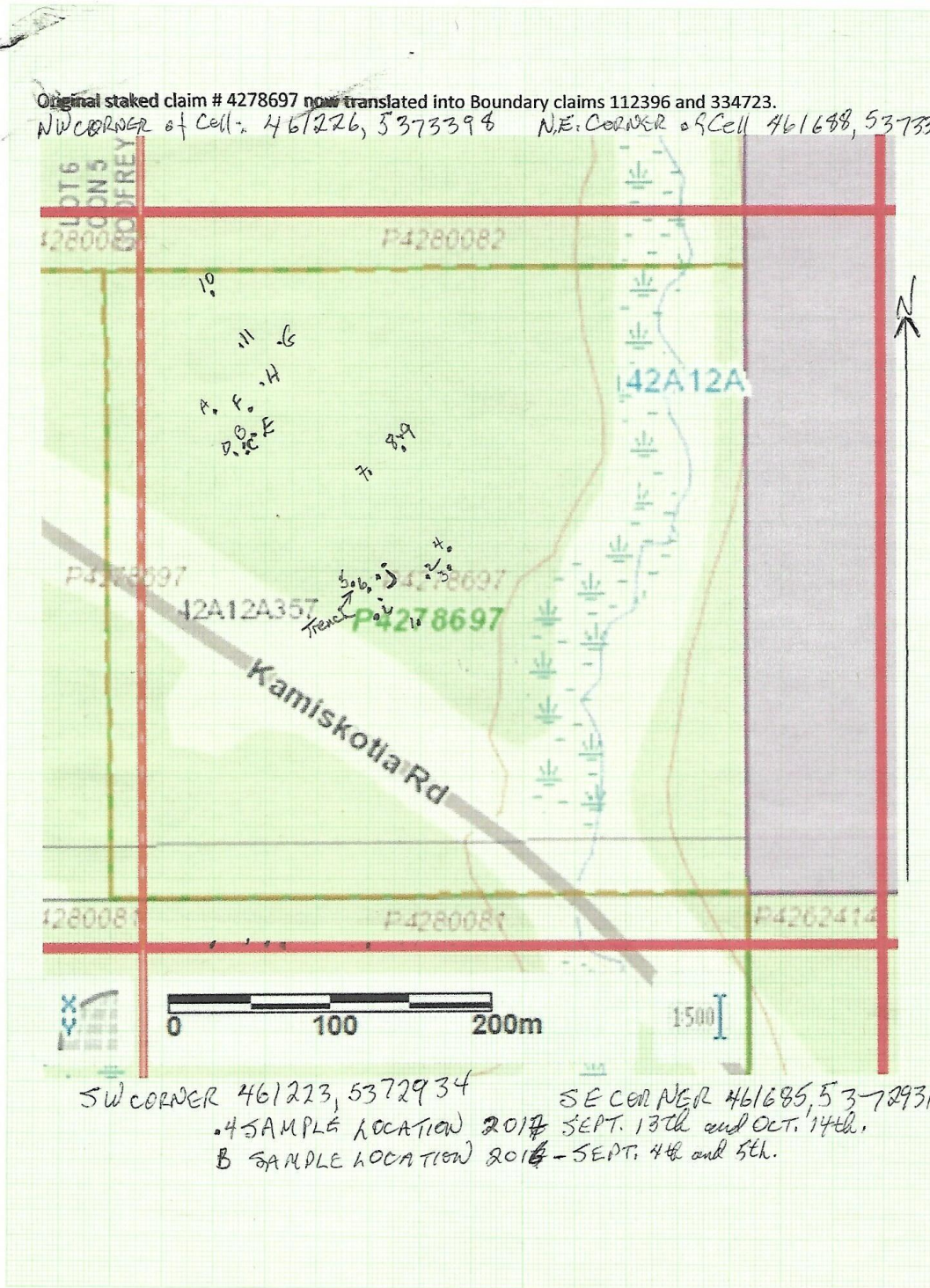
Approximate line of traverse of south Godfrey twship claim for assessment work. Sept 2016.
