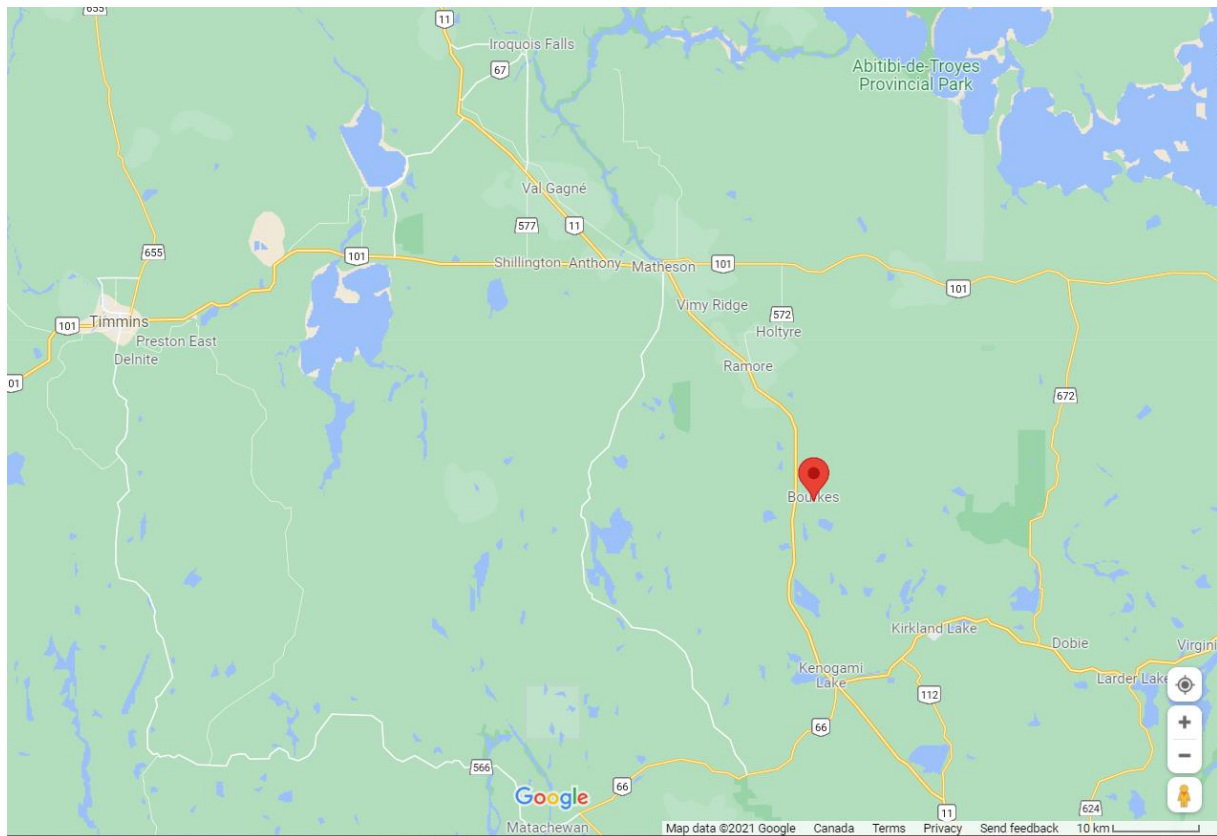

## Location

The Skjonsby Property is located in Benoit Township approximately 20 km northwest of Kirkland Lake, Ontario. The grass roots prospecting work carried out covers claims numbered 275582, 255478, 220383, 188194, 117353 and 117352 located within the Larder Lake Mining Division (See figure 1).

## Access

The Skjonsby Property is approximately 1.5km off highway 11 along the north side of the Bourkes Road. The claim unit's encompass the former Davior Mine (Bourkes Mine).

## Prospecting Work

This report covers the prospecting work carried out during the fall of 2021 on the 6 claims performed by Tim Skjonsby (302221) and Kim Skjonby (10004983).

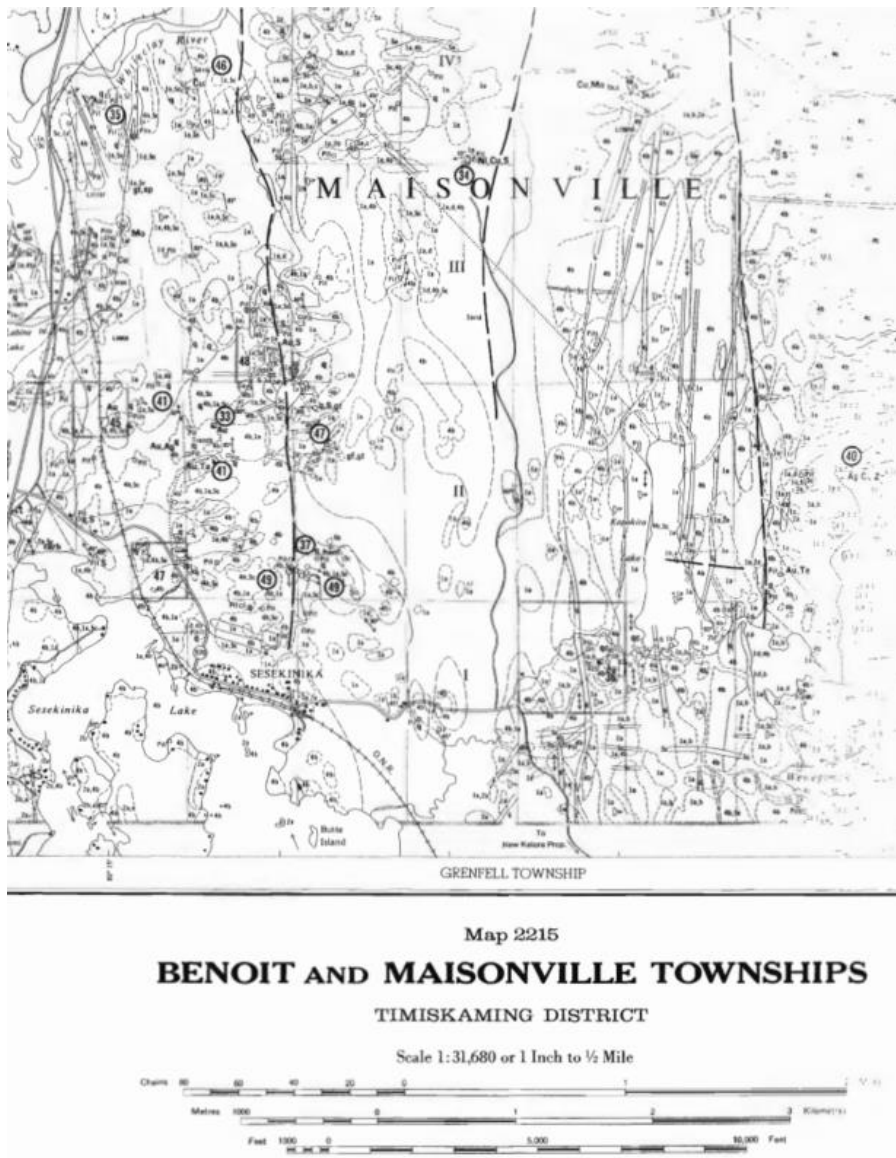


Figure 2 - ODM Geology Map 2215

The claims cover possible ore extensions from the Davior Mine (Bourkes Mine). The ODM Geology Map 2215 (See figure 2) illustrate a north 30 degree shear zone. The claims encompass this trend

## **October 17, 2021**

Traversed claim #255478 and 188194. Located numerous boulders and outcrops. Located drill holes 92-B-39 and 92-B-37. Marked drill holes with metal fence posts and flagging tape. Located and exposed old test trench along WhiteClay River. Samples 2 and 3 were taken at this location. Verified that the rock is a mafic basalt, which; is supported from previous exploration programs. Located what appeared to be a partially milled sample from behind an old mill foundation. Sample 1 was taken from this location. Numerous drill holes by the former Northern Gold, junior mining company, were located in this general location. Pickets and flagging tape were used to assist in possible future location. (See attached map – Skjonsby Property)

## **October 23, 2021**

Traversed claim #275582, 220383, 117353 and 117352. Numerous outcrops and glacial boulders were noted. Located and exposed old test pit along Bourkes road. Sample 4 taken at this location. Located a few old trenches and test pits. Most were filled with water and debris and not accessible without a dewatering plan. The old Davidor Mine shaft cap was closely inspected and appears to be in excellent condition. Metal fence posts were driven into ground around shaft and orange snow fence attached. 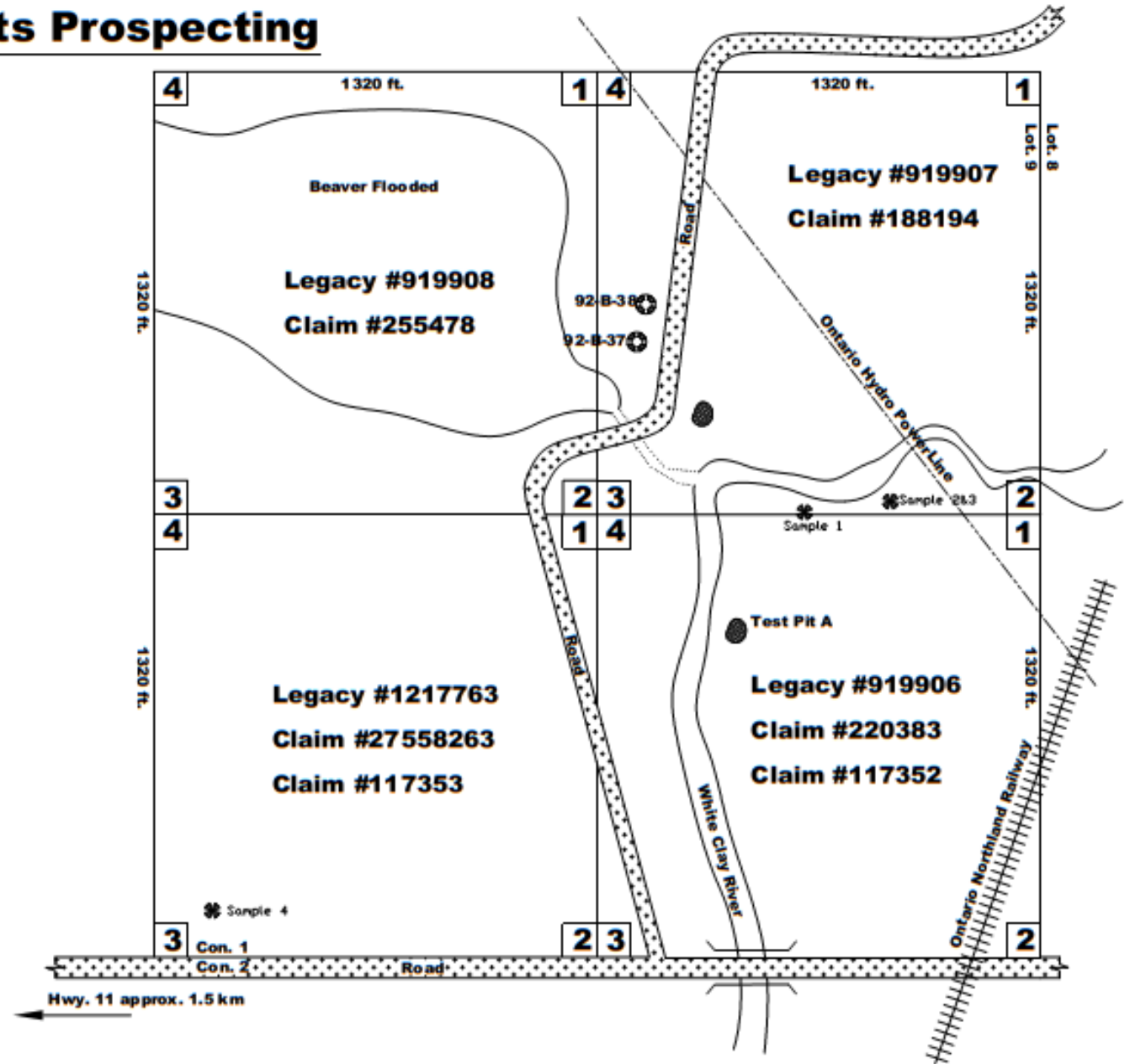
