


Pictures & Map of where we mobilize from at Diamond Willow Amethyst Mine.

We have approved your Assessment Work Submission with the above noted transaction ID for a total of \$10,810 a reduction of \$1,120 has occurred. 1) The trail clearing (blazing) conducted in areas 8 & 9 were not associated with exploratory work in that area. You may file the trail clearing (\$1,120) with the future exploratory work that is planned this year ("....outcrops of good quality amethyst veins which we want to continue exploring in 2021.") 2) The work type "Prospecting – Grass Roots Prospecting" has been changed to "Manual Work" to better reflect the work being done. 3) When filing exploration work in MLAS, only include the claims where the work was done. In this case, the work was conducted on LEA-107759, 118917, 282482, 516034, 516035 and 516038. 


Prospecting in area #9

On Nov 5 2021 trip #1 Two of us had conducted prospecting on claim # 282482 &118917, we had arrived at the Diamond Willow Amethyst Mine and we used our atv (arctic cat 550 and 700) and drove to area 9 to do some prospecting and inspect future work to be performed. We drove within approximately 25' of the area to be prospected from the trail we previously cleared and widened up in 2020. We walked thru the brush and started inspecting the vein outcrops. We discovered Amethyst vein that ran in and out of the bedrock, the vein is near a hydro line, we did a bit of grub hoeing throughout the the vein and noticed there was previous exploration work done here, we grubbed back some of the loose rock in the vein to see what kind of potential the vein has, since the previous exploration work took place small trees and shrubs grew up over some of the area and some of the bedrock remains exposed. More clearing of the site will be required for better access, there is access along the hydro line however to get down to the veins It is a slippery slope bedrock which one must be extremely careful. On the northeast section there appeared to be better outcrops and potential for mining amethyst and had a better colour red and 2 cm crystal size than than on the southwest section which crystals were more of an off white yellow and poor crystal structure. We plan on performing in 2022, 3 blasts along the vein using blast matts as we are close to the hydro line. The blast will better show us what the potential will be.

Prospecting and blasting is Area #8

On Nov 7, 2021, trip #2 two of us had conducted prospecting on claim # 214384 & 516034, we had arrived at the Diamond Willow Amethyst Mine and we used our atv (arctic cat 550 and 700) and drove to area 8 for prospecting and to inspect future work to be performed. It was known that previous exploration work was preformed, mechanical stripping and mining. We started inspecting the thin veining on the on section on the map labelled grub hoe work, these have small pockets showing light coloured purple to clear amethyst of small crystal size. The areas closer to trees had been covered over. The veining in the exposed area was very thin quartz veins, we grub slightly around this area closer to the trees and brush as it did not require much and looked similar to the exposed areas. We started following the vein and inspected the veining from that point to the area we chose to blast which is labelled on the map line of vein and blasting. Closer to the area of the blast the veining was covered over with dirt, moss and previous overburden. This was on a slightly slopped section and a little rugged, we grub hoed a section approximately 16' and decided that we would plan for 3 holes 5' apart.

On November 8th 2021 trip #3 We rented a compressor on (Nov 6 though November 9th) and gathered up my drill and air hose and used my atv to pull the compressor in to the site, I made trips back and forth to the mine, the atv was only good for pulling the compressor for one trip, bringing the hose and air drill up 2nd trip, after drilling bring the drill back to the mine, bring compressor back, we then picked up from our magazine explosives and blasted the 3 holes. I had one blast guard on the trail and help survey the area for people in the area.

The holes we 3' hold approximately 5' apart and 3' deep. I managed to get one piece of recognizable amethyst out of the blast of good purple colour with not so good crystal structure. The rest was what appeared to be quartz. The rock also appeared to granite.


