


Location and Access

The claims are accessed by logging road 13 km. north of highway 560 west , 3 km. West of Gowganda. Gowganda is a hamlet located 40 km. west of Elk Lake in the Nicol Township.

The terrain consists of clear cut forest as well as pine, spruce, birch and poplar stands, as well as numerous swampy areas .

Outcrop on the claim area is found mostly on north-south trending dykes.


Overburden consisting of sand and gravel covers about 50% of the area. Numerous lakes and creeks are found in the area.



Claim Ownership

The claims are held 100% in the name of Sherry Swain.

The claims worked on are 615155, 228320,228318,228319



Previous Work

Work was done by myself in 2018.

Before that there is no recorded work.

The area has an old shaft and equipment left dating back to the early 1900's.

An old ore dump in which high grade samples of copper were found and some old trenches were still visible.

Traverse – May 15,2021

8 am – travelled 14 km from Gowganda within 500 m the old mine site on claim 228320 9 am- prospected claim 228320 east to claim line and then north

11:00 am- walked from end of logging road to along claim line of claims 228319 and 228310. The claim line follows a diabase ridge which is clear cut on the west of the ridge and forested on the east . Out crops of grey porphrytic syenite are in contact with the diabase ridge. Clear cut areas had abundant sand and gravel.

1:00 pm-Prospected around the old shaft and trench and took samples D01,D02,D03 claim 228320.

3:00pm- Prospected north of the old shaft on claims 615155 and 228318. Little outcrop was noted and it was diabase.

4:00- travelled back to Gowganda

Traverse- June 13, 2022

8 am- travelled 14 km from Gowganda with 100m of old mine shaft on Claim 228320 9 am-prospected along dirt logging road and which was in an area of sand and gravel 10 am- sampled outcrop at old mine site and old trench and pit.

Recent logging had filled in an old trench that was visible last season. Only the western end of the trench was visible.


12:30 pm- prospected north/west of the trench on claim 615155 and found out crop of a grey ultramafic in the clearcut. No mineralization was noted.

2:00 pm — prospected north/east along a skidder trail onto claim 228318 to the end of the logging road. The diabase ridge runs north/east of the old mine. There is abundant sand and gravel in this area.


3:30 pm- travelld back to Gowganda

1 do-0515447 E, 5291270 N

Coarse grained red syenite with quartz and silvery pyrite. 1.3 ppm Co, 10 ppb Au

2 do----0515446 E, 5291278 N

Fine grained pink grey syenite with narrow quartz/calcite veins. Black mineral on quartz vein with rust. 10 ppb Au

3 do----0515447 E, 5291283 N

Brecciated quartz vein with orange staining and chalcopyrite in seams. 12.2 ppmCo 3.433% Cu

4 do- 515435E, 5291258N—60ppb Au Red syenite, brecciated, with pyrite

No assays taken for the following June 13 – 2022 –

#1 - 515417 E, 5291287 N

Reddish grey syenite, fine grained with quartz eyes and pink felsic inclusions

#2- 515416E, 5291287 N

Purple grey syenite with quartz / calcite veins, orange staining, minor pyrite, massive

#3-- 515416E, 5291297 N

Dark grey fine grained diabase in contact with rusty quartz vein. Minor chalcopyrite Fine yellow oxide on narrow quartz stringers

#4-515417 E, 5291338 N

Grey syenite with narrow quartz stringers, pink felsic inclusions, no mineralization was observed

#5-515461E, 5291238N

Fine grained, grey/ purplish with talc. Quartz srtingers with chalcopyrite and felsic inclusions.

#6-515454 E, 5291256N

Brecciated quartz, stained orange with dark grey elongated cystals

Conclusion


The high grade copper in the 3 do sample is worth further investigation.

The brecciated quartz vein with pyrite may be worth investigating for the gold potential. The recent logging has covered the original trench discovered last year, but the end of the trench is still accessible.

The amount of work carried out in the early 1900's was probably a result of the silver rush. It seems that the sought after commodity was copper, but that is speculation and cobalt may be present as well.

Worthwhile investigating further.
