INTRODUCTION

The following report will deal with the results of a preliminary prospecting program carried out on the Melgund Township Gold Property on behalf of 2060014 Ontario Inc. The property consists of two, single cell mining claims located in Melgund Township. The work was carried out by Vision Exploration.

A total of 4 travel days and 1 field day were spent by two individuals, in an attempt to locate the historic Pathfinder Showing (1945), as indicated by MDI52F09SW00005. A total of 4 grab samples were taken from the property, two of which will be sent for assay. The purpose of this program was to locate and confirm the previously reported gold occurrence as well as the associated gold values. This work was carried out on October 15th and 25th, 2022.

This report will deal with the results of the preliminary prospecting program carried out on the above-mentioned property.

LOCATION AND ACCESS

The Melgund Township Property consists of a block of 2 contiguous single claims located in the south-western portion of Melgund Township, Kenora, Mining Division (Figure #2).

The property is located approximately 43km southeast of the town of Dryden, Ontario. Access to the work area was gained by taking Hwy 17east from the town of Dryden for 43km to the village of Borups Corners. From Hwy 17 one must take Sandy point road south for approx. 5km to the junction of Sandy Point Road #2. Travelling approximately 2.5km west on Sandy Point Road#2 provides access to within 1km to the southeast of the Pathfinder Showing. From this point the property was accessed by ATV to very near the reported location of the Pathfinder Showing

PREVIOUS WORK




WORK PROGRAM

The current work program involved spending 4 days travelling from Crystal Falls and prospecting the subject claim. The area of the reported Pathfinder Showing was traversed extensively with no indications of old working encountered. It should be noted that the night before the prospecting was to be carried out the region received 3-4 inches of wet snow, making visibility in the thick bush very difficult. It is quite possible that the old workings reported were very near the area traversed but could not be seen.

The geology within the area was found to be a basalt, with little to no sulphide content, although some areas did contain minor alteration and carbonatization. A total of 4 grab samples were taken from the property, with 2 that contained minor sulphides being sent for assay.

SURVEY RESULTS

A total of 1 day was spent on the property by a prospector and helper in an attempt to locate the historic Pathfinder Occurrence (1945). Despite traversing the area thoroughly, no old working could be located. The geology in the area was shown to be north-east trending basalt with little evidence of sulphides and minor amounts of alteration and carbonatization. The topography consisted of random areas of outcropping with no distinct trend. The low-lying areas were covered by black spruce swamp along with alders.

Samples ME-2 and ME 3 will be sent for Au assay.

- ME-1: Basalt with minor alteration, no sulphides were present UTM: Zone 15, 545031mE/5488468mN
- ME-2: Basalt with minor carbanization and trace sulphides. UTM: Zone 15, 545023mE/5488514mN
- ME-3: Basalt with minor sulphides. UTM: Zone 15, 544879mE/5488615mN
- ME-4: Weakly altered Basalt with no visible sulphides. UTM: Zone 15, 545053mE/5488658mN

RECOMMENDATIONS AND CONCLUSIONS

The prospecting program carried out on the Melgund Project did not locate the historic Pathfinder showing. This is not entirely surprising since the coordinates were taken from the Mineral Deposit Inventory on the MLAS system. Many of these showing have been entered on to the map as best as possible but sometime the information used is very vague or not correct. It is quite possible that this showing could be several hundred meters from where it is plotted. This being said, the fact that the area was covered with 3-4 inches of fresh snow makes it possible that the showing could not be seen. This combined with the fact that the historic workings are from pre-1945, another attempt should be made to locate the workings. In addition to this, the AD75 showing from 1991, located in the southern portion of the property should also be investigated.

The prospecting did however indicate a geological environment favourable for gold deposition. The assay results from the 2 samples taken were not available at the time of writing due to backlogs at the assay lab. These results will be submitted once they are received.

As mentioned, the geological environment in the area is favourable and as a result a more extensive prospecting program should be carried out to cover the remainder of the property.
