



#### **Previous work**


As of now, we could not find any reports of previous work done or recorded on the claim. However their is lots of reports of mining and exploration in the area.



## Daily log


On April 29th, 2022, Patrick Jutras, Roger Quenneville, Charles J Beaudry and Alain Robillard left Azilda, Ontario to do some prospecting on claim 653132. It's a 180km drive to the claim. Once at the location, we make plans for the following morning.

On April 30th, 2022 between 8am and 11am, the four of us had covered the lower section highlighted on the map. We were limited by the lake and lower wet sections. At this point we had not found any minerals of interests. We stoped for lunch and started exploring the west side of the claim but north of the road. That afternoon, we found or first sign of quartz. ( see attached map on page 7 As of now, we could not find any reports of previous work done or recorded on the claim. However their is lots of reports of mining and exploration in the area.) . A sample has been colected but has not been sent in for analysing yet.



On May 1st 2022 between 8am and 10am we explored the south east side of the claim. We found a secound quartz vein. No sample of the second vein has been colected at this time. The lower section of the road is covered in water and the ground is flooded for a about 15 meters on either side of the road. At approximatly 10am, we started to explore the the east section north of the road. At 11am we stopped for a quick lunch and continued exploring that section until approximatly 4pm. The terrain varies from lower wet section to rocky terrain. We haven't found anything of interest in this section as of yet.

5pm we head back home.



#### **Results**

After prospecting the better part of the mining claim it has been determined that there is bedrock exposed in the area and some quartz has been found in a couple locations.

A map of the mining claim is attached with the location of the said quartz veins. There is also a deposit of sand and gravel in on the claim. A sample was collected from #1 on the map and will be sent in for analysing in the near future.

No mining has been done date but further prospecting appears to be warranted. The location is close to a developing gold mine and serounded by abandoned gold and iron mines.


