


Map #1

The prospecting on claim 1118441 consisted of 4 traverses. The traverses led to manual stripping and sampling at two sites, one day near the west shore of Cooper Lake and two days near the old shaft of Ogistoh Mines. The rock types encountered were Cobalt Group sediments, conglomerates, argillites etc. overlying granitic and quartz diorite intrusives. These have been intruded later by Nippissing Diabase dikes.

<u>Map # II</u>

MAY 20/94 Traverse

Began at outcrop on west shore of Cooper Lake $\underline{1}$ This outcrop is Nippissing diabase. Proceeding west the ground is covered by overburden. At site $\underline{2}$ an old trench strikes E/W and leads to site $\underline{3}$ a pit were a small amount of sulphide mineralization was observed. The rock is a dark granitic type. Proceeding west over a steep ridge overburden was encountered $\underline{4}$ all the way to steep drop off $\underline{5}$. Turning north outcrops were rock sampled at $\underline{5}$, $\underline{6}$, $\underline{7}$, $\underline{8}$. The rock type is the same dark granitic type with small amounts of sulphide mineralization. At site $\underline{9}$ near the #1 post a large old pit was thoroughly checked, no mineralization was observed. The rock type was a light coloured granitic. Turning south overburden is encountered $\underline{10}$ till the ground rises sharply to the top of the ridge $\underline{11}$. Some mineralization was encountered here associated with small stringers of quartz.

MAY 21/94 Traverse

Proceeding west from the shore of Cooper Lake an old pit $\underline{1}$ was checked but appeared to have little mineralization. The rock type was Nippissing diabase. Traveling north westerly no outcrops are encountered because of overburden. The ground is gently rising past site $\underline{2}$ to site $\underline{3}$. Outcroppings along the ridge are numerous. The rock type at $\underline{3}$ and $\underline{4}$ is a dark granitic.

OCTOBER 5/94 Stripping and Sampling

On one of the above traverses a sample was taken for rock identification. On latter observation at home it proved to be of more interest than in the field. (Latter assayed 30400 ppm Cu 101.2 ppm Ag) A day was spent looking for that sample location and stripping and sampling along the east side of the hill. Three grab samples were assayed. The mineralization was associated with the quartz veins mentioned in the previous traverse. More and wider veins were exposed (90° in length). They were quite lensey. The widest being about 6 inches.

<u>MAP # III</u>

August 3/94 Traverse

Left road at #3 post and crossed a small creek after dropping down a very steep hill. WE then crossed about a claim length of overburdened ground $\underline{1}$ typical of the ground on the south east side of the steep ridges in this area. Turning north and climbing up a steep ridge outcrops were encountered at site $\underline{2}$ and $\underline{3}$. These sites have a medium amount of sulphide mineralization. Turning south at site $\underline{4}$ there was more mineralization at an outcrop overlooking a sharp drop to the swampy ground to the south. Part of our objective on this traverse was to find the old shaft and workings. As proved latter we missed it by only a few hundred feet.


September 5/94 Traverse

The object of this traverse was to find the old workings from the Cooper Lake side. On a compass bearing due west we crossed swampy ground $\underline{1}$ till we came on the shaft and workings $\underline{2}$ and $\underline{3}$. The rock type is quartz diorite in contact with Nippissing diabase. Observations were made in this area (detail map) and samples taken. A trail was then cut back to Cooper Lake.

October 18 & 21/94 Stripping & Sampling




