

54.86 274.32 ULTRAMAFIC BRECCIA

This rock consists of 15 to 25% fragments set in a light to medium greenish grey ground mass. The ground mass has been moderately to intensely serpentinized. Lighter areas tend to be richer in chlorite and calcite. Phenocrysts of olivine are present in the matrix, most have been serpentinized and are black, only pseudomorphs remain or they have been completely leached away. Fragments make up 15 to 25% of the rock ranging in size from 1 to 15cm. The mean is 5cm range. Colours vary from light green and white to black. They range from fg to mg and are occasionally intensely serpentinized and soft.

The total hole remained consistent throughout except for occasional minor fragment choked intervals. These sections also often contained larger fragments.


