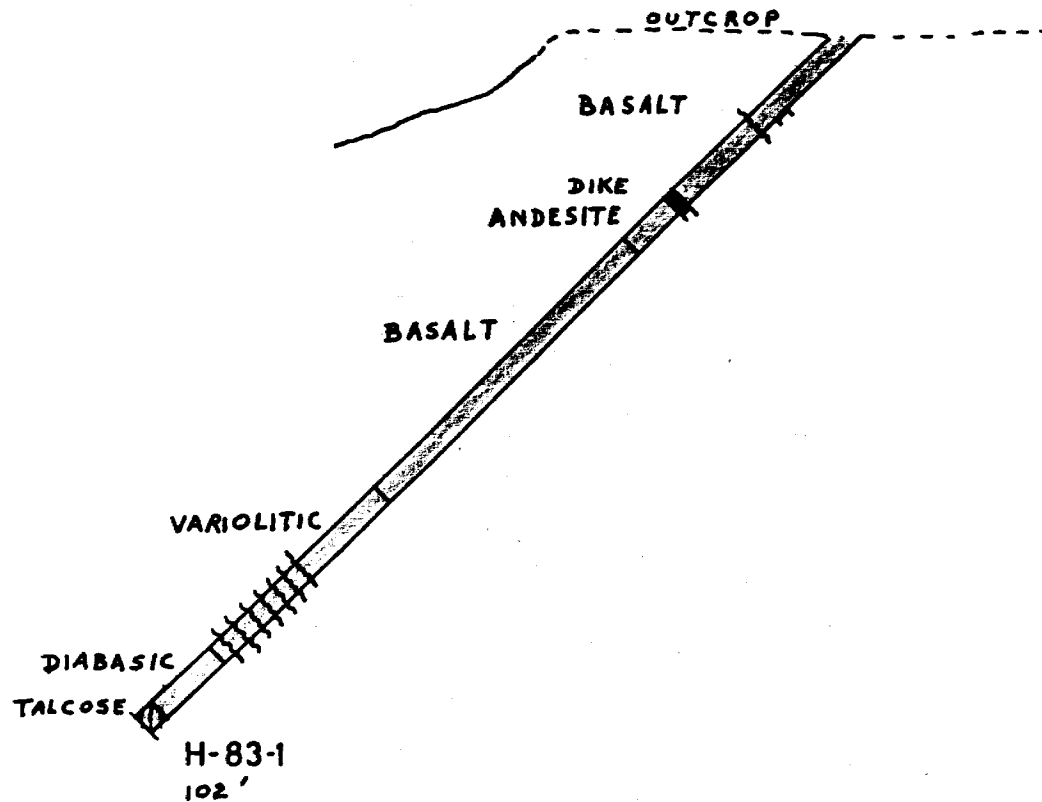

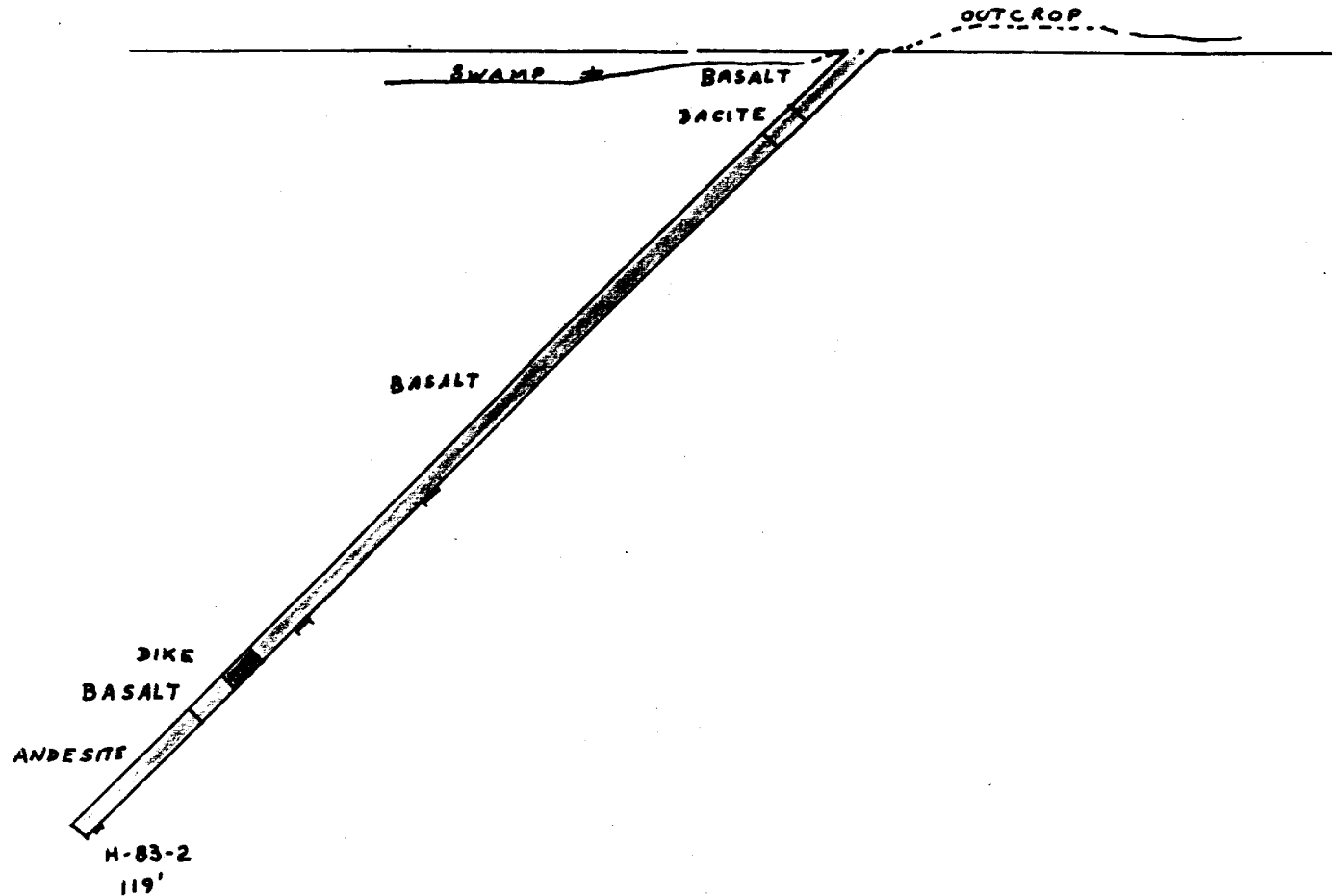

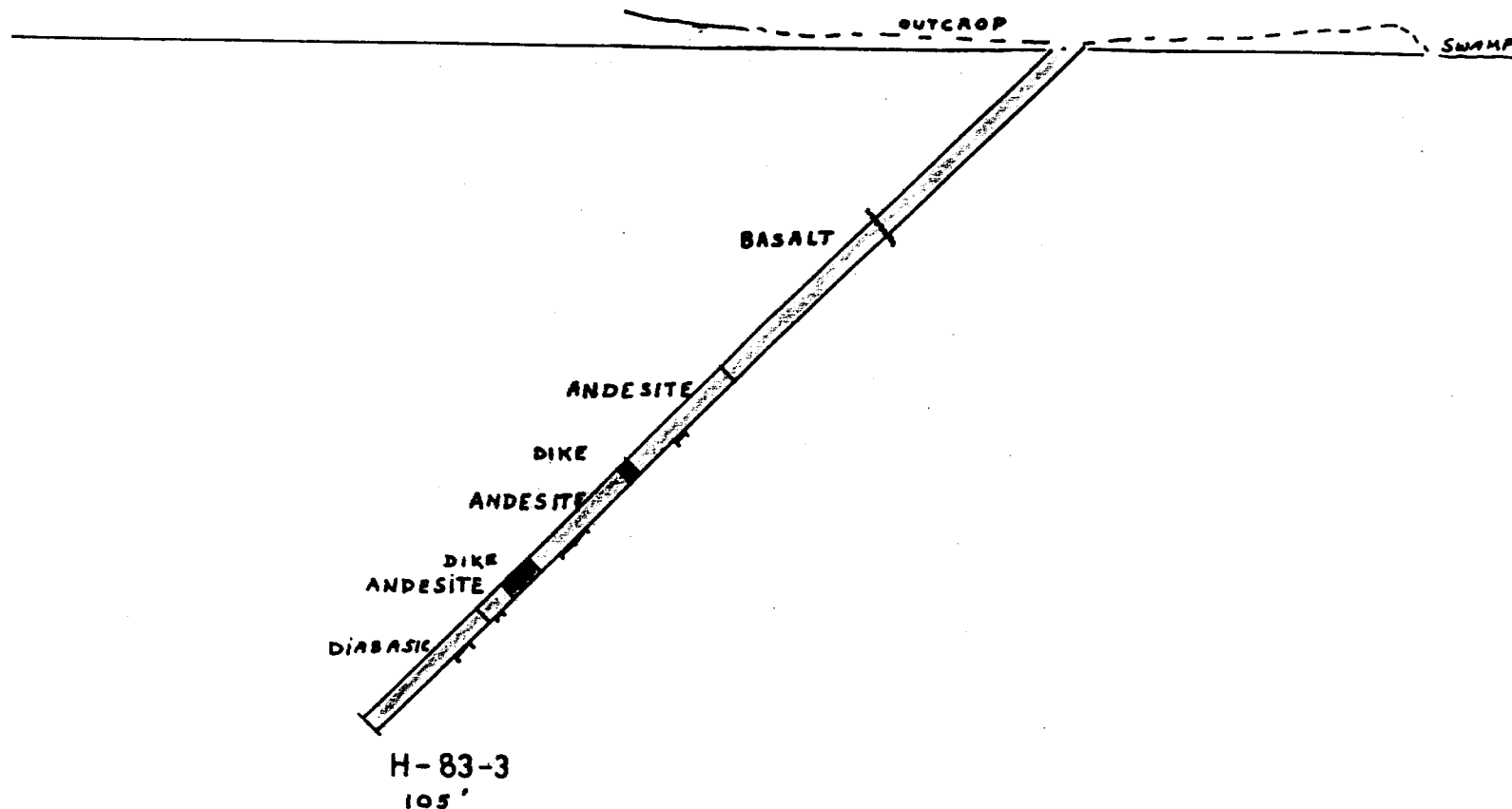


HOLE H-83-1

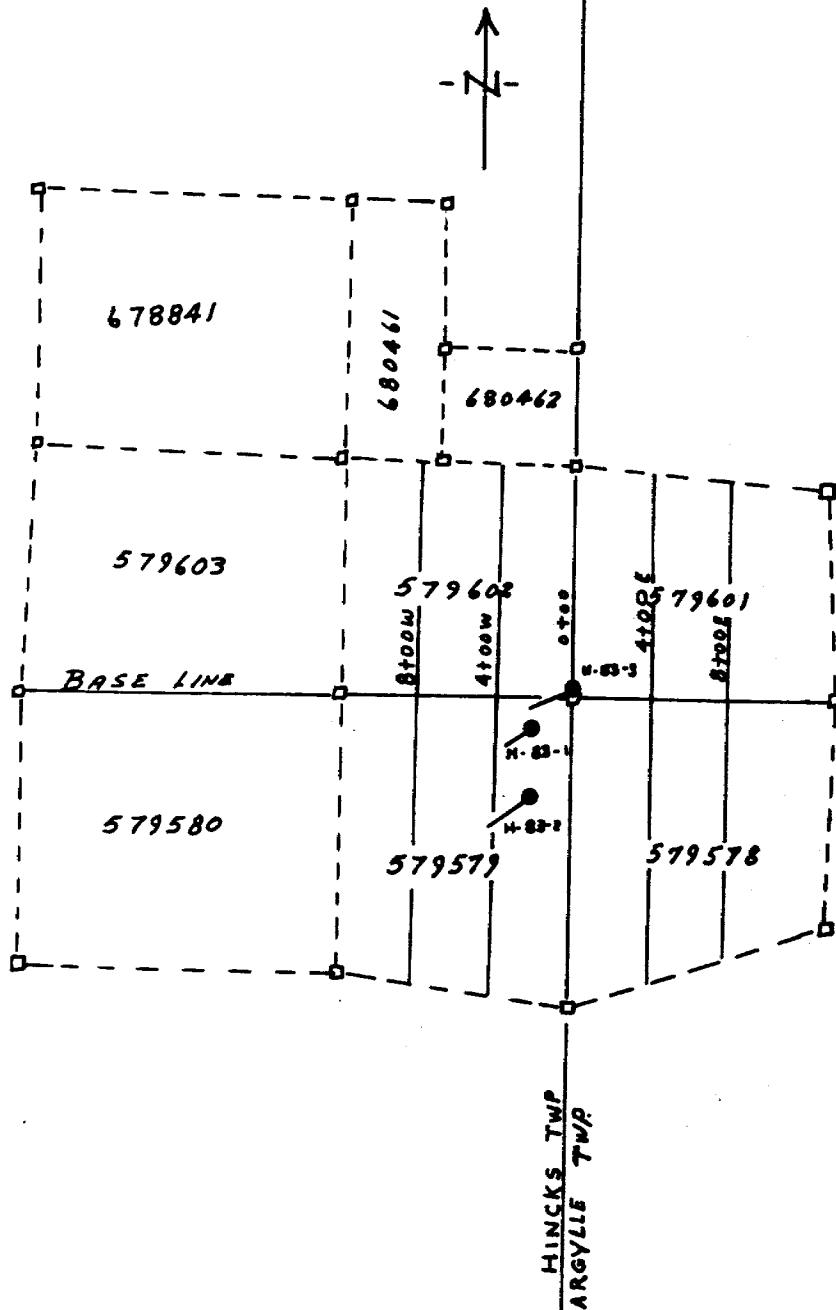


HOLE H-83-2

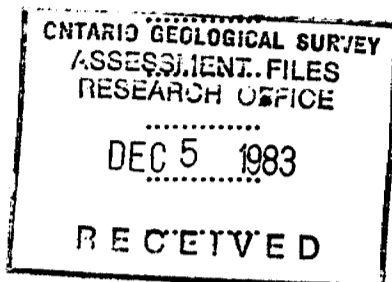

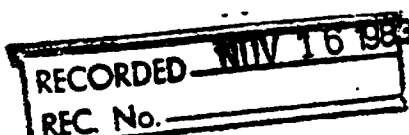
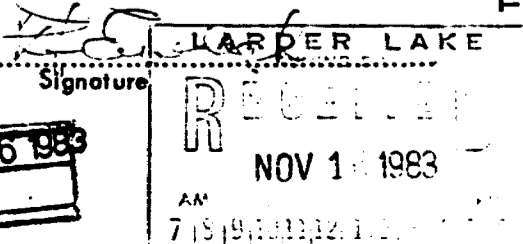
