OP90-437 + OP90-438 1.) Property Holder, Number of Claims:

The property consists of 29 claims.

Mrs. Lucy Larche holds claim number No. P 1132889.

Mr. Vital Larche holds the remaining claims No. 1132861 - 1132888

2.) Location and Access:

The claim group lies about 40 miles southwest of Timmins, Ontario in the central portion of Kenogaming Township. Access is via the Kenogaming Lumber Road, a good gravel road leading south off Highway 101 that connects Timmins and Foleyet. It is about 14 km from the paved Highway 101 to the property.

3.) Geology:

The area is well documented by the Geological Report 97 - Geology of the Sewell Lake Area by V.G.Milne, 1972. Felsic to intermediate metavolcanics underlie most of the property. These have been intruded by a feldspar porphyry that is exposed east of Crawford Lake. In addition, North - South diabase dikes traverse the area. Faults and shear zones cut the formations and quartz veining is associated with them. Sulphides, mainly pyrite, and gold have been associated in some locations in this township with the shear zones.

4.) Work Done, Results and Recommendations:

Surface prospecting by Mr. (Vital) and Mrs. (Lucy) Larche was carried out July 8 - July 12, 1990.

Nine areas of interest where shearing, quartz veining, and pyrite mineralization occurred were selected. The areas were buildozed,

cleared of trees, trenched and rock sampled. All of the 159 'Grab - Channel' rock samples assayed less than

0.005 oz/ton gold.

Two claims, P-1132861 and P1132889, were covered by VLF EM16 and magnetic surveys with rather negative results.- Refer to Geophysical report by Maxwell Juby.

The entire claim group could be covered by a VLF EM survey with followup prospecting of the significant conductors to try to locate gold bearing shear zones.
