### 3.a) Project Description and Target:

The bedrock stone on the test site is barren, exposed with very little covering soil, with a few stunted spruce trees, blueberry bushes and lichen. The bedrock stone is a white pegmatite referred to in the stone industry as white granite. The site is oblong exposed elevated, barren bedrock, 20 meters above the surrounding countryside. The project would involve removal by a diamond wire saw, numerous quarry test blocks to be fabricated into dimensional stone of various sizes for architectural building stone, interior, exterior stone panelling, flooring tiles, counter tops and fabricated dimension stone for outdoor kitchens, patios, pavers and retaining walls etc. The principle target is to have these test blocks and stone products presented to potential stone buyers in the industry for their opinion and possible acceptance as a sellable stone product for various uses in the stone industries. Additional bedrock stripping, core drilling and ASTM (stone properties lab testing) will further determine the site for quarryable stone.

### 3.b) Mining History:

There is no previous mining or dimension stone production known in the area regarding this white granite. Several mining companies have been active through the years, core drilling for rare earth elements, lithium, tantalum etc. My only purpose is for quarry block extraction for dimension stone markets.

### 3.c) Access Description

At Hwy 11-17 and Hwy 527 junction approximately 2 km east of Thunder Bay city limits, turn north on Hwy 527 (a paved highway) for 50 km to the Dorion Cut- off road, on your right hand side; the road has a sign Dorion Cut-off. Travel east on this gravel Logging road for almost exactly 10 km. to a sign on left, (Manchester Road). Turn left (north) on this gravel Logging road exactly the 8 km. sign, this brings you into the NE section of the claim. Our test site is near this location on another small haul road to your left (west) approx. 200 meters off the Manchester Road. Please see: Regional Location and Access Map, page 4 and Access Map, page 5) attached.

### 3.d) Term and Operation of Project

Depending on how the licensing and weather is we would like to get a start on the project in May of this spring and possibly completing it before freeze up this year. I am working on several locations, trying to get enough test samples out this year, however if I don't complete the test blocks this summer season I'm sure we'll complete it before freeze up next year. If the site fails as a dimension stone quarry, rehabilitation will be completed immediately. The term of the Bulk Permit license is for 3 years and that may be the term required, depending on the unknown test results and sample requests. If the site becomes acceptable at any time, I would immediately apply for a quarry permit.



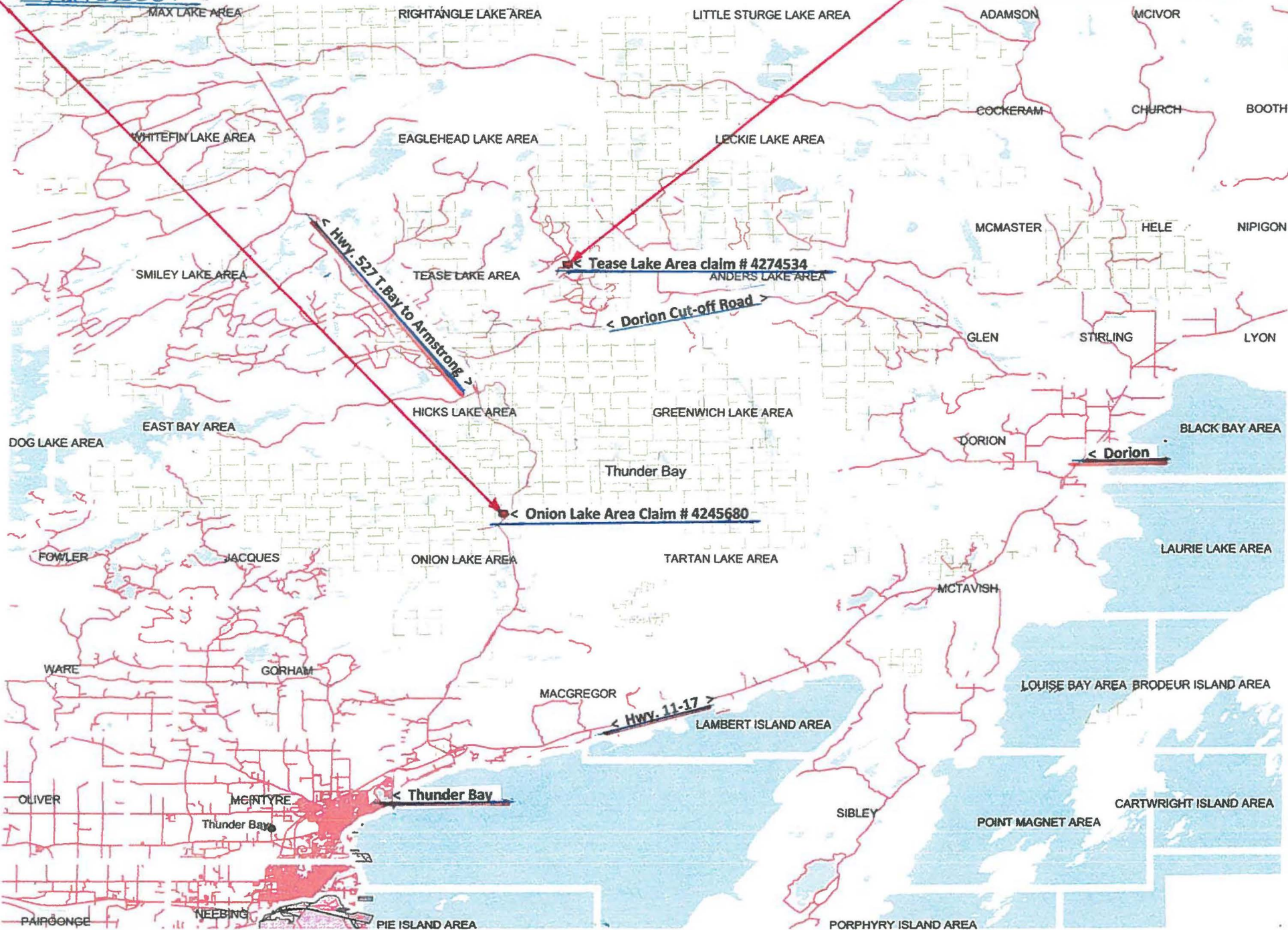
REGIONAL LOCATION & ACCESS

New Bulk Permit Locations Map

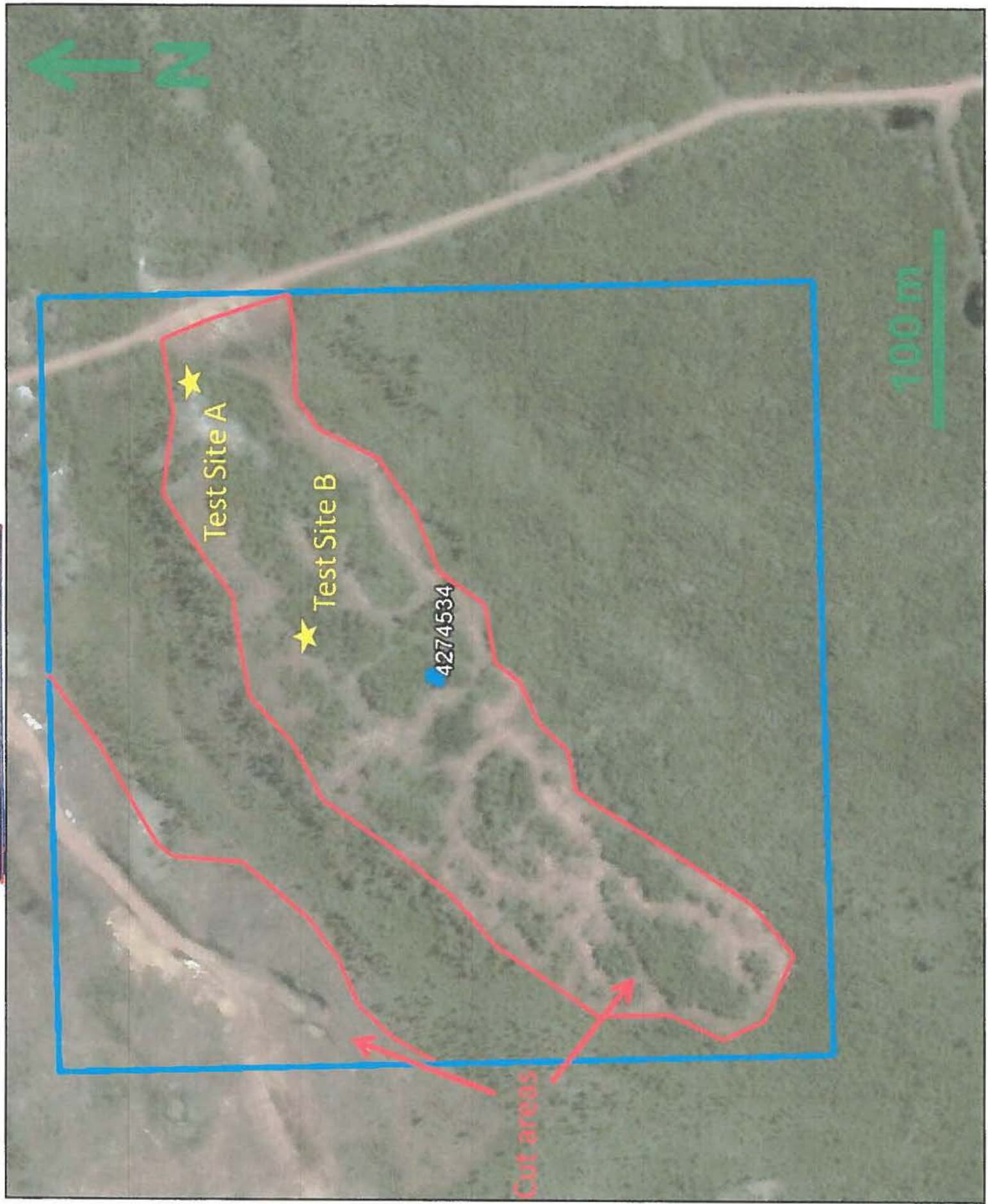

## Summary of Environment

The claim area has been logged over by the forest industry in the past and has been staked several times by the mining industry, for rare earth elements, lithium etc. The area has a network of bush roads from previous and current logging activities, the Dorion cut off road and the Manchester road that goes through the northeast corner of this claim was just recently upgraded for current logging. The logging in the past was primarily softwood (spruce and jackpine) and has been scarified and replanted with the same wood species.

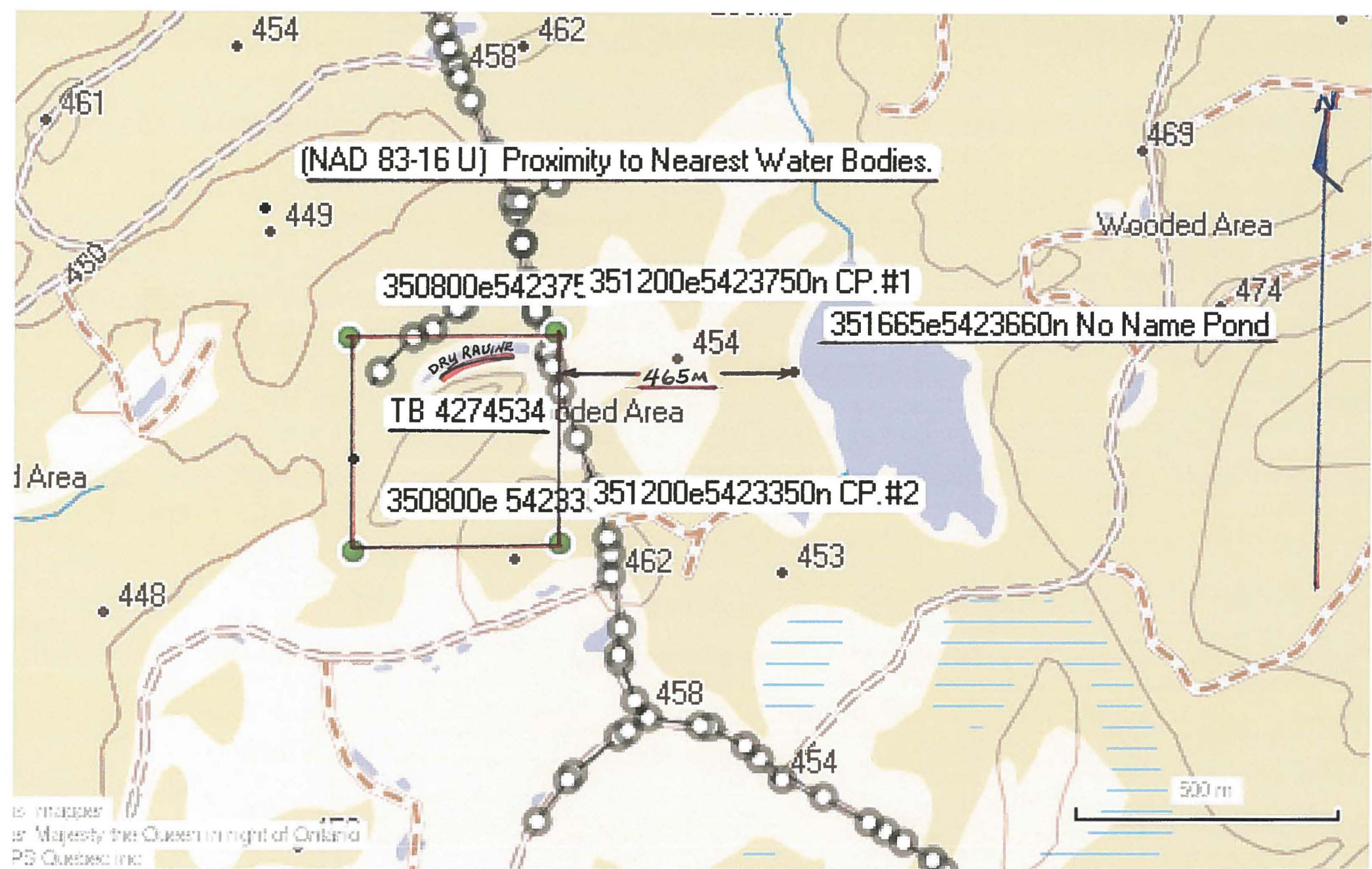
Most of my claim and surrounding areas are shallow soil with intermittent sand and humus soils and my claim on this exposed bedrock outcrop has very shallow sporadic humus soil with lichen covering some barren rock with blueberry bushes and some stunted growth of jackpine trees.

My chosen test site, centrally located on the claim is on barren white pegmatite bedrock 20 meters above the surrounding countryside.

The site is located 500 meters west of a small pond of approximately 16 hectares and another pond 1.8 km to the west, which drains into Manchester Lake 3.4 km to the west as well. There is a low lying narrow swamp in the claim directly north, adjacent to the elevated prospect which is completely surrounded by elevated bedrock and there is no indication of water flowing in or out of this lower lying crevice in the bedrock. This swamp ravine has no open water (I walked through it when I staked my north claim line) and I didn't notice any aquatic, frogs or salamanders, during earlier prospecting in the spring or summer of last year. There is no streams or ponds on the test site.

On my various travels to the site I saw one bull moose 5 km south of the claim last summer and quite often saw partridge on the Dorion cut off and Manchester road to this site at various times. No other signs or sightings were encountered.
