ENDM invites you to identify and communicate any concerns or comments in relation to ENDM's consideration of appropriate terms and conditions for the renewed mining leases.

We do not anticipate any new environmental impacts associated with the renewal of these leases. The ongoing environmental effects of the Ojibway salt mine are managed and mitigated through other regulatory processes and not through the terms of the leases.
