10. For submitting an application to exchange a lease for replacement leases under subsection 83(1), per replacement lease.	\$255.00	No tax
11. For appealing a decision of the Tribunal under subsection 152(11).	\$51.00	No tax
12. For issuing or validating an unpatented mining claim, licence of occupation, lease, or patent under subsection 176(3).	\$1,200.00	No tax
13. For submitting a notice to retain an interest in surrendered mining lands in the form of unpatented mining claims, under subsection 183(2), per mining claim.	\$85.00	No tax
14. For a request for an order of the Minister under section 185 of the <i>Act</i> revoking, cancelling or annulling the forfeiture of any mining lands or mining rights or the termination of a lease or relieving from forfeiture any mining claims, per application.	\$1,200.00	No tax
15. For recording an agreement, power of attorney, writ of execution or any other instrument affecting a mining claim, or a recorded right or interest under subsection 60(1), per mining claim.	\$20.00	No tax
16. For a copy of a document or record obtained from the Provincial Recording Office per quarter hour of service.	\$7.50/15 minutes	HST
17. For a certified copy of a document, record, or inspection report obtained from the Provincial Recording Office.	\$7.50/15 minutes	HST
18. For a mining claim abstract.	\$7.50/15 minutes	HST
19. For a certified copy of a mining claim abstract.	\$7.50/15 minutes	HST
20. Mining Land Tax Fine/Penalty.	\$50.00	No tax
21. For an application for the transfer of forfeited interest in properties under subsections 184(4) and 184(5) of the <i>Mining Act</i> .	\$1,200.00	No tax
