**SECTION 35, THE MINING ACT, R.S.O. 1990**

**ORDER NO. W-P-36/19**

The MINING RIGHTS of the area outlined in red on the attached sketch, situated in the Township of Deloro, Porcupine Mining Division, containing 13.96 hectares more or less, are hereby WITHDRAWN from prospecting, mining claim registration, sale or lease.

This area is WITHDRAWN for the maintenance and administration under Part VII of the Mining Act.

Saving, excepting and reserving hereto and herefrom, all other lands patented, sold, leased or otherwise alienated by the Crown at the date of this Order.

Any alienated lands lying within the limits of this withdrawn area that revert to the Crown subsequent to the date of this Order will automatically be considered to be withdrawn as part of this Order.

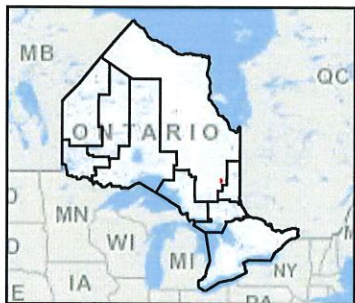
